"This match was very exciting," Coach Orth said. "We played the ball really well when volleying. Atwood had some really good serves that took us by surprise.


"The girls never gave up and came back to play a close third set and ended up on top.

Mr. Lacy reported that CMS (Centers for Medicare and Medicaid Services) had increased the hospital's interim payment.

The hospital, he said, will be increasing charges in areas where the charges do not cover the costs. These changes are based on cost to charge ratios, payor mix, and environment.

The hospital showed lower total patient service revenue but expenses were up for August. Charity care was up for the month. Both clinics showed a profit for the month.
