## E-waste pick up starts this coming new year

karen.k@nwkansas.com Christmas is almost here and Santa has orders to bring new televisions, computers and microwaves, organization has been able to offer just to name a few of those electronic gifts. Now, what do residents do with the old equipment?

If residents will just hold on to those items until after the first of the year, said Roger Jensen, coordinator and representative of the Northwest Kansas Regional Recycling Organization board, we will have a collection.

In the past, grant money has paid for the collection of these items but that grant has run out. Seeing the importance of having a place to bring televisions, computers and other items, the board has agreed to send a semi to St. Francis so people from the county can bring in their items.

This collection will cost those bringing items in 25-cents a pound. This just pays for the cost of transportation, Mr. Jensen said.

For the last two year, the Northwest Kansas Regional Recycling free e-waste pick up because of a grant. During those two years, the eight counties involved brought in over 200 tons of e-waste items to the Colby center.

Today, the center is also a retail store where a volunteer comes in, repairs and cleans up much of the items. The recycled items are then sold at a minimal cost.

Some of the items considered for e-waste collection are: computers, parts and accessories, printers, scanners, fax machines, copy machines, telephones, cellular phones, answering machines, televisions, stereos, DVD and VCR players, speakers, radios, tape recorders, satellite receivers, toner and ink-jet cartridges, computer games and rechargeable batteries.

# Foundations work together

The Bird City Century II Development Foundation and the St. Francis Community Foundation have joined forces to accept charitable contributions. These contributions will support those public and charitable entities that provide or support senior housing and/or long-term care in Cheyenne County for the aged and those in need. Both foundations have established identical funds named "Senior Living for Cheyenne County Fund,' and the combined funds will be utilized for the same purpose.

The October fire at the Good Samaritan Village was the disaster that prompted the two boards to work together by creating a vehicle to accept charitable contributions for this cause. The county commissioners recently appointed a task force to study the current and future needs of longterm care in the county. This task force will work with the advisory boards for these two funds to ensure continuity and communication throughout the county for this project.

The combined funds will initially be used to cover the expenses incurred by the task force in researching the current and future needs for longterm care and assisted living. The role of the Senior Living for Cheyenne County Fund Advisory Board is to raise awareness, raise funds for the 'Senior Living for Cheyenne County Funds," and suggest grants from these funds.

The Bird City Century II Development Foundation and the St. Francis Community Foundation held a joint meeting on Dec. 9 with local attorneys, accountants and financial planners to educate and agree to establish these Senior Living funds. 




