

Wrestlers tie for seventh at regionals

betty.w@nwkansas.com Two St. Francis wrestlers will be going to the 3-2-1A state tournament at Hays this Friday and Saturday. Senior Adam Guthmiller will return to state as he placed first at 215 pounds at the Goodland 3-2-1A Regional tournament on Saturday and freshman Lane Hoffman will be attending state as he placed first at 103 pounds. Guthmiller did not place at state last year but gained valuable experience.

Norton was the winner of the 3-2-1A Regional wrestling tournament on Friday and Saturday. The Blue Jays collected 187 points. St. Francis tied for seventh with Cimmaron with 71 points.

Placing second at Goodland was Hoxie with 175.5 points. Scott City was third with 134 points and Goodland fourth with 133 points.

Also participating for St. Francis at regionals were 112: Casey Keller; 125: Michael Leibbrandt; 130: Logan Lampe; 135: David Leibbrandt 140: Tyler Raby; 145: Derek Queen; 152: Dylan Wolaver; 189: Zach Gienger.

A number of St. Francis team points were earned by wrestlers who won matches even though they did not qualify for state.

"We wrestled well on the backside," Coach Nathan Smith said. "Our young kids really came along this year and have expressed interest in continuing to get better during the offseason. I think the program's future looks bright with the quality young men we have in it now and will be joining us next year."
