Some residents clean up property

karen.k@nwkansas.com Property cleanup was at the top of the St. Francis City Council's agenda. The city superintendent said, some residents are following through with cleanup.

Superintendent J.R. Landenberger reported that there was lots of progress at the Figgins property on East Fourth Street.

However, there had been people complaining about the Sauer residence on West Webster Street. The complaints had been made to the city attorney's office.

A house on West Whittier Street, across from Goodell Greenhouse was discussed. The house is unoccupied except for an abundance of cats and Mr. Landenberger reported that it has mold on the basement walls. The house is presently in a trust.

The tree work on the Neitzel property on South River Street has been done by the city but there has been no communication with the property owner.

The council discussed the fact that the county attorney, in a commissioners' meeting, had discussed having a delinquent property tax sale. This type of sale, the council agreed, would help clear up some of the city's problem with vacant properties.

Trailer parking

At the last meeting, there had been complaints about the trailers parked on Main Street. Chief of police, Shane Guggenmos, said the officers are working on talking to the owners of the trailers but noted that some of the owners are not very receptive to moving them.

Radios for the police department were once again discussed. The police chief and Superintendent Landenberger had discussed that there is no room for the radios in the police budget and there is a problem with other things needed in other funds.

The 800 megahertz radios he had proposed getting would be going off the introductory price of \$999 each. Eventually, the department will need to have the radios, he said. There will be more information concerning the budget at the end of the month. They will look at the radios again then.

Pool report

Bruce Swihart, councilman, gave the swimming pool report, noting that the pool had gone over budget and another pay period was still coming in. Next year, he said, summer between the end and start of the school year will be shorter, thus, there will be less days that the pool is open.

He noted that Mikaela Grace, manager, and Christina Schoenrogge, lifeguard, did some maintenance work at the pool. The office floor, he said, has never looked so good.

Building permits

Building permits were approved for Delbert Barnhart to run a sidewalk; Mark Cooper, build garage extension; Mary Bier, take down a house; Danny Penton, remove and replace a porch; Kim and Kary Zweygardt, deck; and Toby Dirks, fence.

They didn't approve a permit for Sean Straub to build a garage on his Jackson Street property. Mr. Landenberger said he though it would cause a drainage problem to others down the block but understood that it would help Straub's drainage problem.

I just can't issue something that will put a problem on someone else, Mr. Landenberger said.

He asked that the council take time to look at it and the matter will be addressed at a later meeting

Landen-Superintendent berger said he had talked to Bob Krutsinger about putting in two blocks of curb and gutter on Washington Street. Mr. Krutsinger will still do the work for \$25,000.

Electric rates were discussed. Figures of rates in surrounding cities were distributed but no decision was made.

Carla Lampe and Paula Keller, councilwomen, went with Mr. Landenberger to check out the landscaping at the Scout Hut. After looking at the options, they all agreed that concrete around the building would be the best solution. The cost would be around \$3,000 compared to \$1,500 to \$1,800 for wood chips which would probably be thrown in play.

The signs for U.S. 36 have come in, Mr. Landenberger said. Specific heights for the signs are needed before they can be put

The council approved to have the scum line on the swimming pool painted royal blue. It will cost about \$480 in paint and will be done this fall. They also talked about repairing the facia on the pool house. because of the roofing materials, the facia cannot be replaced. It will need to be scraped and sanded and then painted.

The pump for the lift station is ordered but will take four to six weeks. The good pump is still running, he said.

The new remote-read water meters have been ordered.
