At Just Teazn, Brandee will offer hair cuts and styling for women, men and children.

"I have a 'kid friendly' shop," she said. "Many people work full time and it is necessary to bring their kids with them to have their hair fixed."

Brandee also gives perms, does colors and "up dos." In the near future, she will have the feather hair extensions.

Other services are nails and pedicures as well as tanning which will include the tanning bed or spray tanning. Ms. Sasse said she is licensed and trained to operate the tanning bed and is trained to special room for each of the tanning processes.

At the present time, she offers acrylic nails but in the near future, she will be adding shellac polishes which are new on the market. The shellac polish lasts for at least 14

days without chipping, scratching or smudging, she said.

Brandee graduated from Boswell High School in Fort Worth, Texas. When she was 30, she had breast cancer. My beautician, Brandee said, was so helpful when I started losing my hair. I wanted to be able to help people like she helped me.
