Council discusses landfill violation

The St. Francis City Council met on March 12 at the city office. A topic of concern was the violation the county landfill had received from the Kansas Department of Health and Environment.

An ordinance already on the books requiring all light weight trash to be bagged will be more strictly enforced. A more in-depth story will be in a future issue of the Herald.

Scott Carmichael, St. Francis Community Schools Principal, thanked city superintendent, J.R. Landenberger, and police chief, Shane Guggenmos, for their work with the schools and community.

The council heard from Carl and Kate Jenkins. The Jenkins are planning to open a bed and breakfast and had over 80 percent of the signatures from neighbors needed for a zoning variance, which was approved.

One bid was received for replacing 10 trees on Main Street. The bid was from Troy Porter for \$8,770 and it was approved.

New owners of the St. Francis Sand and Redi-Mix, Darrel and Pamela Ritchey, applied to the city for the Small Business Incentive. It was approved.

The council talked about the health insurance for the city employees again and will keep it the same as last year, and will look at some more information from Mr. Landenberger at the next meeting.

There were two building permits: Dave Straub for a fence and Joe Peter to pour concrete. Both were approved.

Superintendent report

Mr. Landenberger talked about creating a sign plan, as required by the federal government. This is just a written proposal as to how the city will replace road signs as time goes on. The city is currently in compliance and may look into getting a machine that could make the signs. An engineer came to town and

Mr. Landenberger said there are some poles on the school property that are no longer used and that the city would remove them.

If not, they will hire Matt Whitmore. Aly Marin is interested in water safety instruction and will enquire about that at St. Joe's in Missouri. Margaret Poling will continue aquacise.

Opening day is May 26 and Brett Lampe, Christina Schoenrogge and Matt Whitmore have been hired. Mr. Swihart said he had readvertised for two more part-time lifeguards and will talk to Red Cross about certification.

For the council comments, council member Paula Keller had talked with someone passing through town who stayed at the roadside park and inquired about adding electrical hookups. They talked about it and will get more information for the next meeting.

Council member Roger Jensen asked Mrs. Milne if she had been receiving emails from the western Kansas Rural Economic Development Alliance. She said she would check on it.

Council member Carla Lampe said the next economic development committee meeting would be at 7:30 a.m. on March 22.

More good economic news for Kansas-there were 22,000 private sector jobs created last year. Eight of the 11 major industries in Kansas reported over-the-year job gains. Due to a decline of the seasonally adjusted unemployment rate to below 6.5 percent, the State Extended Benefits program will expire in Kansas on April 7.
