 "On some very severely stricken fields," said Falk, "we expected to see some really high numbers. We were somewhat surprised to find that wasn't always the case.

"You've got to know what your nitrate levels are, and the only real way to do that is to have a sample tested at the lab."

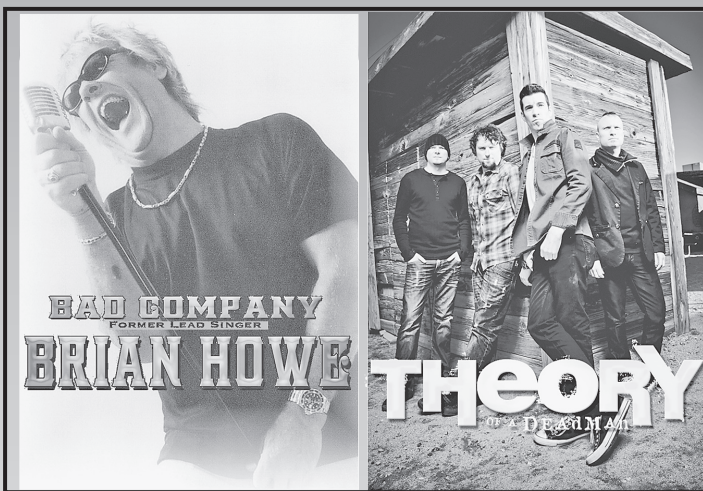
