FRANCIS KANSAS; INCORPORATING BY REFERENCE THE "STANDARD TRAFFIC ORDINANCE FOR KANSAS CITIES," **EDITION OF 2013, AMENDING SECTION 101 OF ARTICLE 14** OF THE 2003 CODE OF THE CITY OF ST. FRANCIS, KANSAS AND REPEALING ORDINANCE NO. 587.

BE IT ORDAINED BY THE GOVERNING BODY OF THE CITY OF ST. FRANCIS, KANSAS, that Ordinance No. 587 be repealed and that Section 101 of Article 14 of the 2003 Code of the City of St. Francis Kansas and entitled "INCORPORATING STANDARD TRAFFIC **ORDINANCE**" is hereby amended to read as follows:
