# Hospital board names interim leader

The hospital board voted unanimously to recommend Les Lacy as the interim Chief Executive Officer of the Cheyenne County Hospital after Judy Rockwood's resignation and departure during the board meeting last Tuesday. Mr. Lacy, speaking as representative of Great Plains Health Alliance as well, said that the process of finding a new CEO could take two to three months, but they are not putting a definite cutoff date on when his interim time will end.

Mr. Lacy said that Great Plains Health Alliance, who manages the hospital in Atwood, has recently hired a new CEO for the Rawlins County Health Center. There are numerous applications from that search that will be useful in hiring a CEO for the Cheyenne County Hospital. He said he will go through those applications and find those that are a good fit, and find two to three candidates to bring to the board.


