The members of the St. Francis City Council and the Cheyenne County Commissioners discussed law enforcement at the July 15 commissioners' meeting. The key words coming from the discussion were "accountability, communication and professionalism." At the end of their meeting, it was agreed that, in the best interest and safety of the people, a contract be drawn up, hiring the sheriff's officers for 15 hours a week plus being on call during business hours. The agreement will start on Aug. 1 and end on Dec. 31. At that time, the matter

will be addressed again. As you know, said Mike Day, city attorney, the city of St. Francis is down to a two-man force. The city council has had an ongoing discussion on how to better use tax dollars.

The commissioners showed concern that the sheriff would be responsible for holidays and weekends but Mr. Day assured them that would not happen. And, he said, if there is a call after hours, the city police force will be on call.

We will work hard to have the level of communication improved upon and be seamless. We will share our schedule with dispatch and the sheriff's depart-

He went on to say that the city council thought it was important that law officers be visible before and after school as well as during the day. If there is an incident, the city officers can respond but, the sheriff officers can also enforce

The city has different statutes than state statutes. The last time we tried this (helping out the city), said Ernie Ketzner, commissioner, it didn't work because our officers stepped on some toes and a city councilman blew up. I'm not going to let this happen again; I'm not going to have someone chew Cody (Beeson,

If there is a city violation, Mr. Day said, the sheriff will handle it. The city police department will respond when there is a larger issue. If there is an event, we

city, county and dispatch should be able to work those things out.

If we are going to do this, said Brett Poling, commissioner, we will do it with professionalism and communication.

Dale Patton, commissioner, said the contract to cover law enforcement in the city of Bird City has worked pretty well. I am concerned about our staffing level we need to make sure we have enough force to facilitate this avenue. He went on to say that when services are duplicated, the tax money is getting "burned." The sheriff's office does have

an obligation to cover services for everyone in the county, said Roger Jensen, councilman, but the city is not asking for free gratis. We are willing to pay.

Sheriff Beeson had already studied the costs per hour per officer which included salary, benefits, vehicle and other costs. It will cost \$38.90 per hour, he said.

Paula Keller, city council woman, asked the sheriff if he could work with the city police force. The sheriff answered, "yes." Right now it is fine and I am optimistic about the future. My concern is holidays and we need to know what the city ordinances are. There might be some rough times but I think we can work matters out, he said. The matter of golf carts driven

in the city limits was brought up. Sheriff Beeson said the ordinance in Bird City allows golf carts driven on city streets. In this case, we let city ordinances override state ordinances as long as the driver is a licensed driver.

I just don't want the sheriff's office always being the bad guy, Sheriff Beeson said.

We are asking for an agreement, not a city marshal, Mr. Day said.

Mr. Day will meet with Karan Thadani, county attorney, to draw up a contract. A special meeting may be held to discuss any prob-

Sheriff Beeson then requested 10 minutes executive session to discuss personnel. Upon return to regular session, Sheriff Beeson was given permission to place an ad in the paper for a deputy sher-
