Wells Fargo forecloses on real Animal identification program started

Every once in a while, someone in Strasburg or Vona or some other small town in Colorado will release the brakes on a railroad car. It will start rolling down hill very slowly at first but over the course of about 100 miles, it will reach speeds of up to 70 miles per hour. By passing House Bill 2593 we are unleashing a force that, as the railroad car does, always ends

At this time, the Kansas Livestock Association will have access to all the numbers of cattle in the state, where they are and who owns them. Over the course of a few years, they will also know how each producer's cattle graded when slaughtered. It's possible for them to offer you as a producer a service tracking your cattle from the cow to the packer, thus giving you the ability to improve your herd genetics. You, as a producer, will be forced to pay a fee for this service, plus, a membership in that organization. This will finance their operation from a three has always stood before the legis-

The issue of this bill is who controls the data. Data is a valuable commodity to those that control it.
