# General notice published to control noxious weeds in county

Published in The St. Francis Herald, St. Francis, Kansas, and The Bird City Times, Bird City, Kansas, Thursdays March 11 and March 18, 2004. (11-12)  
**GENERAL NOTICE TO CONTROL NOXIOUS WEEDS**  
 The Kansas Noxious Weed Law K.S.A. 2-1314 et seq requires all persons who own or supervise land in Kansas to control and eradicate all weeds declared noxious by legislative action. The weeds declared noxious are: field bindweed, musk thistle, sericea lespedeza, johnson grass, bur ragweed, Canada thistle, leafy spurge, hoary cress, quack grass, Russian knapweed, kudzu and pignut. Bull thistle is County Option Noxious Weed/Weeds declared noxious by the Board of County Commissioners of Cheyenne County. Notice is hereby given pursuant to the Kansas Noxious Weed Law to every person who owns or supervised land in Cheyenne County that noxious weeds growing or found on such land shall be controlled and eradicated. Control is defined as preventing the production of viable seed and the vegetative spread of the plant.  
 Failure to observe this notice may result in the County:  
 1. Serving a legal notice requiring

control of the noxious weeds within a minimum of five days. Failure to control the noxious weeds within the time period allowed may result in the county treating the noxious weeds at the landowners expense and placing a lien on the property if the bill is not paid within 30 days or,  
 2. Filing criminal charges for non compliance. Conviction for non compliance may result in a fine of \$100 per day of non-compliance with a maximum fine of \$1500.  
 The public is also hereby notified that it is a violation of the Kansas Noxious Weed Law to barter, sell or give away infested nursery stock or livestock feed unless the feed is fed on the farm where grown or sold to a commercial processor that will destroy the viability of the noxious weed seed. Custom harvesting machines must be labeled with a label provided by the Kansas Dept. of Agriculture and must be free of all weed seed and litter when entering the State and when leaving a field infested with noxious weeds. Additional information may be obtained from the Cheyenne County Noxious Weed Department or by contacting the Kansas Dept. of Agriculture, 109 S.W. 9th, Topeka, KS 66612.

# Advice offered for turkey hunters

Nearly every outdoorsman has a child, friend, or neighborhood youth who asks questions about outdoor experiences. Often, these youngsters are dropping subtle hints that they want to go hunting or fishing. Spring turkey hunting is the perfect opportunity to get those curious youth involved in the outdoors.  
 "The early morning sights and sounds of spring are usually more exciting to most kids than an action-packed video game," says Bruce Taggart, Region 1 Public Lands supervisor for the Kansas Department of Wildlife and Parks. "And gobbling turkeys aren't the only source of excitement. Booming prairie chickens, crowing pheasants, whistling quail, and howling coyotes are just a few of the sounds to be heard. A slow-moving opossum may ramble by the blind, deer may feed nearby, and squirrels may comb the ground for food just feet away.  
 "Of course, turkey are the main attraction," Mr. Taggart continues, "and there's nothing like the sight of turkeys flying off the roost and strutting right in front of you. But if the turkeys don't cooperate, there is always the chance of finding a mess of more mushrooms or a hidden deer

shed antler. These are experiences that I guarantee will have a kid wanting to go again and again."  
 Mr. Taggart urges caution when introducing the youth to the outdoors and turkey hunting because they can be easily overwhelmed. Turkey hunting for adults requires early mornings, extensive walking, and long periods of sitting.  
 "Most first-time kids can't handle too much early morning stress," Mr. Taggart explains. "Go at their speed. Take them on a morning hunt on Saturday and an evening hunt on Sunday. Scout the area you are planning to take them and find the shortest walk to the area where you will set up. Time the outing so they do not have to sit for

hours on end. Build a blind so they can move around a little and take some snacks and drinks. Camouflage them well and let them call, and they'll feel like a part of the hunt, not a hindrance.  
 "If something goes wrong and the turkey is spooked, don't be upset; it's just a turkey, and there will be more chances. You may only have one chance to keep the youth interested in hunting. Also, many times kids don't have to hunt to have a good time; they just want to come along and learn."  
 Anyone wishing to take a youth turkey hunting has a special opportunity the weekend before regular turkey season. April 9-11 are the dates for the spring youth turkey season.

During this season, only youth 16 and younger may hunt, but they must be accompanied by an adult 21 years old or older. (The regular season runs April 14-May 31.) A hunter education certificate is required, in addition to a spring turkey permit.  
 "Practice shooting at stationary targets the size of a turkey's head is essential," says Mr. Taggart. "Pop cans on a stick stuck in the ground work well for this. Also, take them with you to gain private land permission and explain the importance of good land-owner relations.  
 "While it may be a little more work to take a kid hunting, the end reward is well worth it and could result in a life long hunting companion."

# Farmers with losses on crop, livestock may apply for loan

Farm Service Agency loans covering production losses may be used to buy feed, seed, fertilizer, livestock, or to make payments on real estate and chattel debts.  
 "Funds can also be used for other essential operating and living expenses," he said.  
 To be eligible for an emergency disaster loan, an applicant must be operating a family size farm or ranch, must be unable to get credit elsewhere, and must have suffered a qualifying physical and/or production loss from the disaster.  
 Farmers who suffered at least a 30 percent reduction to at least one cropping enterprise, may have a

qualifying production loss. Emergency disaster production loss loans cover 100 percent of qualifying losses. Loan availability is limited to \$500,000, less the outstanding principal balance of any and all prior emergency loans.  
 Manager Eckhardt asked that those farmers needing farm credit as a result of drought, excessive wind and insect infestation, which occurred Jan. 1, 2003, and continuing, and who think they are eligible for Farm Service Agency assistance, should make their applications at the Farm Service Agency County Office, Goodland, between the hours of 8 a.m. and 4:30 p.m. Friday.
