Continued from Page 1A cost per person per year for the dispatchers would be \$11.40 with benefits and \$7.08 without benefits.

The council, along with Chief Gardner, thought the cost-share needed to be re-evaluated since the position has become more of a 24hour/seven-day job.

There is approximately \$80,000 in the 911 Fund. However, these funds are designated for equipment only and cannot be used for wages.

Chief Gardner said several decisions needed to be made concerning the dispatchers. Both the chief and superintendent city J.R. Landenberger, do not feel it will be feasible to have the dispatchers headquarters in the power plant.

The department could be moved either to the police department or the old sheriff's office in the courthouse. If moved to either place, the police and sheriff clerk could then be used as part-time for the dispatch position. The cost for the department would then be around \$120,000 in wages and benefits.

The council appointed mayor Scott Schultz to meet with a representative from the Cheyenne County Commis-




