"To be six and one with our late start and assorted injuries just shows what competitors all the guys are," Coach Cassidy said. "When we shoot the ball we can really play."

The Indians finished with a 36.4 field-goal percentage and a 80 percent from the free-throw line (8-10).

AJ had a 75 percent field-goal average making 3-of-4 from beyond the arc and 6-of-9 from twopoint range. He was 4-of-6 from the line. Joel McAtee, Weeden and Crabtree each were 100 percent from the line but were limited to one or two attempts.

Under the basket, J. McAtee and Adam Peter each had six rebounds. The team had an outstanding 40 deflections with Weeden leading

The St. Francis Lady Indians were defeated 42-35 by Rawlins County on Monday, Dec. 18, in a hard-fought battle. The Sainty Ladies kept the Lady

Buffs from scoring a field goal in the fourth quarter but they collected nine points from the free-throw line to take the seven-point victory.

"We played good defense and pounded the offensive boards better than we have been," Coach Ted

Scoring in the first quarter was what carried the Lady Buffs through the game. They had 14 points compared to six for St.

Francis. "We gave them too many offensive boards for points in the first half that led to most of their points in the first quarter," Coach Busse said.

Lauren Ross was 7-of-10 from RC 14 11 08 09 the free-throw line for a 70 percent. She added six two-point shots for a rebounding with nine, seven of them offensive.

Of Sainty's 35 rebounds, 21 of them were offensive. Besides Ross with nine, Alecia Zimbelman had seven and Holly Keller six.

Sidnee Crabtree had the only three-pointer connect although Sainty had nine attempts from beyond the arc.

Ross and Zimbelman each had five steals out of a team total of 15.

The Lady Buffs had a 40-percent field-goal average compared to 24.1 for Sainty. Rawlins County was also 58.8 percent from the freethrow line (10/17) compared to 42.1for the Lady Indians (8/19).

"I do feel that we did get better and that is always the goal," Coach Busse said.

The team will hit the floor immediately at the beginning of January, actually Jan. 2, the night before school resumes on the 3rd. They will travel to Atwood to meet the Rawlins County Buffs.

Edwin Otto Lauer

May 5, 1925 - Dec. 14, 2006 Eddie O. Lauer was born May 5, 1925, on a farm 15 miles northwest of St. Francis, Kan., to Christina (Magstadt) and Adam Lauer. Eddie died on Dec. 14, 2006, at his home in St. Francis.

Preceding him in death were his parents; three brothers, Edwin (who died in infancy), Fred and Rueben; and four sisters, Emma Schield, Anna Harsch, Ella Terrell and Barbara Laws. Eddie was baptized in the

Lutheran Church in St. Francis on June 21, 1925. He was confirmed into the American Evangelical Lutheran Church in St. Francis on June 25, 1939. He was a member of Peace Lutheran Church at the time of his death. Eddie graduated from St.

Francis Community High School in 1942. While in high school, Eddie worked at a service station for Ted Smith and this is how he met his wife Florice (PeeWee) who was the Smith family baby sitter. Eddie and PeeWee were married in St. Francis on Oct. 1, 1944. Their only son Roger was born Oct. 17, 1945.

As a child, Eddie hated farming, but when both his brothers went into the service, Eddie gave up going to college so he could help his dad on the farm.

Then in 1949, Eddie worked for the Bureau of Reclamation when Bonny Dam was being planned. He did part-time survey work in the afternoons.

Also in 1949, the Lauer's bought the cleaning shop on Main Street in St. Francis. Eddie worked with PeeWee in the shop until 1961 when he began working for the ASCS (Agricultural Stabilization and Conservation Service). He started work as a reporter measuring wheat, making farm storage loans, and being a commodity inspector...basically he did "a little bit of everything." When the ASCS office began aerial photography (measuring from a photo map instead of measuring from the ground) the outdoor work began to slow down and he had to make a decision...either work a few months out of the year outside or go inside to desk work. In 1980, Eddie was appointed as Cheyenne County Executive Director and he maintained that position until he retired in 1986 after 25 years with In 1973, Eddie's brother Fred

developed leukemia and needed help on the farm so Eddie helped him out by doing some of the farming after he got off of work. In 1974, he took over operating the farm and continued farming until semi-retirement in 2002. Eddie continued raising cattle up to the time of his death.

Golfing was Eddie's favorite sport until back pain wouldn't let him play anymore so then he started fishing. He usually caught Lutheran Church, where he had a lot of fish and held an annual fish fry at Riverside Recreation for several years. He also loved to hunt...ducks, geese, deer, rabbits, you name it.

Left to mourn his passing are: his wife of 62 years, Florice (PeeWee) of St. Francis, his son, Roger and wife, Darlene of St. Francis, grandson, Gerald and wife, Dawn of St. Francis and their children, Kodi and Tyler, grandson, Greg and wife, Maribeth of Parker, Colo., and their children, Dylan, Alex and Cooper, and many other relatives and

Funeral services were held Dec. 19 at Peace Lutheran Church in St. Francis, with Pastor Ken Hart officiating. Internment was at the St. Francis Cemetery.

K-State offers tips for sledding safety

enne County has already seen measurable snowfall.

To many, a good snowfall means a day of sledding. Sledding equipment available at many retail stores ranges from toboggans to snow disks. For the sake of rider safety, each type of sled is designed to be used in a certain position — either lying down or sitting upright. To help keep snow play safe, use these simple tips:

• Insist that children wear a bicycle helmet for sledding. In addition, wear thick gloves or mittens and warm, waterproof boots.

• Sledders should ride lying down

with feet in front. If you sled down-

It's winter in Kansas and Chey- hill head first, you greatly increase the risk of head injury. Snow disks and plastic sliders are designed for the rider to sit upright. No one should ever ride while standing up.

> • Children, ages 5 to 9, are most susceptible to sledding injuries. Parents of young children should not let them sled alone. • Make sure the sledding path is free

> of hazards such as trees, fences, rocks, wire or bare spots, and does not cross a road. Teach older children to check for these hazards.

• Only sled during daylight hours. • Do not sled on icy hills. The hills should be snow-covered. • Never hitch a sled behind a mov-

ing vehicle. The results can be deadly.
