If Kansas is to continue to be the best place to live for both adults and children we need a way to keep our community growing and prospering. As a result Thomas County was one of 17 counties chosen by the Kansas Health Foundation to receive a grant of \$100,000 to establish an endowment in a permanent foundation. One-half of the interest would go to youth projects and the other half would go for leadership enrichment in our community. Future funds would be used in the area of the donors interests such as, arts, historic preservation, new facilities, events or whatever the intentions of the donors.

We were also given the opportunity to meet yet another challenge from the Kansas Health Foundation. They know that if a foundation is to survive it has to have good solid funding for operations. So, they challenged each of the 17 communities to be a part of a matching grant process. We need to have commitments of \$300,000 by December 31, 2001, and we have until December 31, 2003 for all the pledges to be collected. It is vital that we meet the \$300,000 by the end of the year to qualify for the matching funds. If we can prove that our community is committed we will be given the opportunity for other grants as well. At this time it is up to Thomas County to make a difference in the lives of all citizens of Century. We must ALL pull together to continue to thrive to make Thomas County the special place it is today and tomorrow... the foundation is a tool for surviving.

As a community if one or two people try to accomplish a goal it won't happen BUT if we do it as a total community and we are inclusive, it will happen!


