The wind was certainly fierce on Wednesday afternoon and evening, but I haven't heard of any damage such as Colby had.







David was born in Colby, Kan., December 27, 1960. He lived at the Keller home place near Mingo before the family moved to Page City in 1962. In 1994, he and his family moved back to the home place in Mingo.

Along with his father, David stood to look through tractor steering wheels and under the bellies of cattle as a youngster. As a man he looked with knowledge over each as a young adult, he enjoyed the challenging life of farming.

He farmed many acres of wheat, corn and alfalfa hay in Thomas, Logan and Wallace counties as well as Eastern Colorado and Southwest Kan. along with his brother-in-law and partner Mike Johnson of Colby. They built a 20 plus fleet

truck line in 1988 known as Keller & Johnson Transport, Inc. After 1999, David and Mike pursued their own interests.

The inquisitiveness and drive to become a licensed pilot in high school was the same that took him sky diving and deep sea diving in later years.

His love for outdoor life led him to hunt many animals including: coyotes, quail, pheasants, geese, ducks, deer, antelope and elk. David truly enjoyed fishing with his family at his "Twin Buttes" Ranch at McAllister. He loved going on the Butterfield Trail Ride each year from the time he was a young boy. From the time he began attending, he only missed one year. In his later years, he gave his children that same experience.

Within the circle of diverse activity his most cherished assets were family and friends. David and Jane have two beautiful children, Chase and Audrey. They were David's greatest treasure.

Growing up in a family with four sisters he was challenged. He never lacked for love or advice. With two older sisters, Brenda and Lana, both were very protective of him and he had a duty to protect his two younger sisters, Leanne and Amy.
