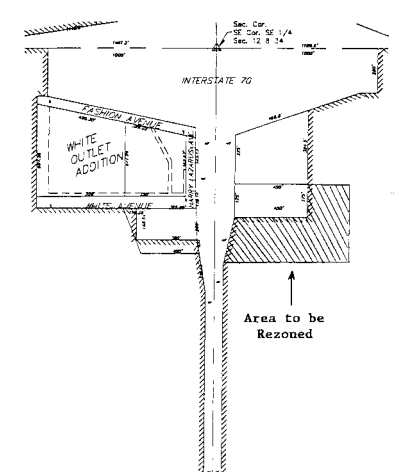
You and each of you are hereby notified that the Colby/Thomas County Metropolitan Area Planning Commission will hold a Public Hearing in the Council Chambers of City Hall, 585 N. Franklin, Colby, Kansas, at 9:30 A.M. on Thursday, March 15, 2001, to hear a request for zoning change from Super 8 Motels of Concordia, Inc., owner, from R-1 (Single Family Dwelling District) to C-2 (Neighborhood Commercial District), more particularly described as follows:

A tract of land located in the Northwest Quarter (NW 1/4) of Section Eighteen (S18), Township Eight South (T08S), Range Thirty-three West (R33W) of the Sixth Principal Meridian (6th P.M.) in Thomas County, Kansas, more particularly described as follows:

Commencing at the northwest corner of said Quarter, thence, on an assumed bearing of S00°24'55"W, along the west line of said Section, a distance of one thousand fifty-five and ninety-five hundredths (1055.95) feet and S89°35'05"E for a distance of one hundred twenty-six and six hundredths (126.06) feet to the point of beginning, said point of beginning being located on the east right-of-way boundary of Highway K-25.


From the point of beginning, thence N88°14'01"E for a distance of four hundred fifty and no hundredths (450.00) feet, thence N00°43'01"E for a distance of one hundred seventy-five and no hundredths (175.00) feet, thence N88°14'01"E for a distance of seven hundred fifty and no hundredths (750.00) feet, thence S00°43'01"W for a distance of five hundred seventy-six and seven hundredths (576.07) feet, thence N89°55'12"W for a distance of one thousand two hundred seventy-six and eighty-eight hundredths (1276.88) feet to the east right-of-way boundary of Highway K-25, thence N26°54'11"E, along said right-of-way, for a distance of one hundred seventy-seven and fifty-one hundredths (177.51) feet, thence N00°34'44"E, along said right-of-way, for a distance of ninety-nine and sixty-four hundredths (99.64) feet, thence N00°37'38"E, along said right-of-way, for a distance of one hundred four and thirty-four hundredths (104.34) feet to the point of beginning, containing 13.66 acres.
