Legal Notice

ORDINANCE NO. 55

AN ORDINANCE DESCRIBING CERTAIN RULES, REGULATIONS, REQUIREMENTS AND PROCEDURES IN REGARDS TO DOGS WITHIN THE CITY LIMITS OF MENLO, KANSAS, AND REPEALING ORDINANCE 50 OF THE CITY OF MENLO, KANSAS.

BE IT ORDAINED BY THE GOVERNING BODY OF THE CITY OF MENLO, KANSAS ON JUNE 25, 2001:

SECTION 1. DEFINITION; HARBORER. Any person who shall allow any dogs to habitually remain or to lodge or be fed within his or her home, store, yard, enclosure or place of business or any other premises in which he or she resides or controls shall be considered as harboring such dog or dogs within the meaning of this Ordinance. Also, any person owning, keeping or harboring a dog within the limits of the City for (3) consecutive days shall be deemed the owner thereof.

SECTION 2. REGISTRATION REQUIRED FEES. The owner, keeper or harboring of any dog over six months of age shall cause the name, sex and description of such dog to be registered by the City Clerk each year pay to the City Clerk a registration fee in the amount of and at the times following: Registration fees shall become due and payable on and after the first day of AUGUST each year, and shall be \$3.50 for each male dog and each spayed female dog; and \$10.00 for each unspayed female dog. On and after September 1st in each year, the fees shall be double the aforesaid amounts, respectively; provided, that persons becoming the owner, keeper or harboring of a dog subsequent to August 1st of each year shall at once register such dog and pay the registration fee applying for the period beginning August 1st of each year.

SECTION 3. ISSUANCE OF DOG LICENSES. It shall be the duty of City Clerk to procure at the expense of the City, such number of suitable tags, numbered serially, with the license year thereon, for the purpose designated in this Ordinance, as may be necessary. It shall also be the duty of the City Clerk to procure and maintain a suitable register of which the Clerk shall keep a record of the names and addresses of all persons to whom licenses are issued together with the names and description of the dogs licensed, and the number of the checks or tags given.

SECTION 4. ANNUAL NOTICE TO BE PUBLISHED. Each year on or before the fifteenth day of July, it shall be the duty of the City Clerk to publish a notice which shall notify owners or harborers of dogs in the City that the annual dog registration fee will be due and payable on or before August 1st following. Such other information as is pertinent may be included in said notice.

SECTION 5. VACCINATION REQUIRED. The rules and regulations governing the vaccination of dogs as follows: (a) Every dog of the age of five (5) months or over, within the corporate limits of the City, shall be immunized against rabies and shall remain so effectively immunized. The owner or harboring of each such dog shall, upon request by proper authority, produce a certificate from a licensed, accredited veterinarian, attesting to the dog's current immunity against rabies. (b) Before any such dog or dogs, shall be registered, as aforesaid, the owner, keeper or harboring thereof shall produce and exhibit to the Clerk, a certificate of some registered veterinary against rabies within the calendar year in which application is made for registration, as aforesaid. (c) The Mayor, upon evidence of rabies in the City or vicinity thereof, shall have the authority to require the vaccination of all dogs within the City. One publication in the official City paper or a written notice to the owners or harborers thereof shall be considered sufficient notice.

SECTION 6. SPAYED FEMALES. In case such application for the registration shall be for a spayed female dog, such application shall be accompanied by a certificate of registered veterinary surgeon showing that such dog has been spayed.

SECTION 7. TAGS. Each person so registering a dog as above required shall at all times cause such dog to wear a suitable metallic check or tag furnished by City with the dogs assigned number and year of registration. In case of the loss of any tag, the City Clerk shall, upon presentation of the receipt originally issued and the payment of \$1.00, issue a new tag. No person shall place upon any dog a tag other than the one given for the particular dog for which it is issued under the registration certificate.

SECTION 8. RULES AND REQUIREMENTS. The owner, keeper or harboring of any dogs shall conform to the following rules and requirements:

- a) NO DOG OR DOGS SHALL BE PERMITTED TO RUN AT LARGE AT ANY TIME IN THE CITY.
- (b) ALL DOGS SHALL BE CONFINED ON THE PREMISES OF THE OWNERS EXCEPT THAT SUCH DOGS MAY BE TAKEN OUT ON A CHAIN OR LEASH OR UNDER VOICE CONTROL.
- (c) EACH AND EVERY DOG OR DOGS WHICH TRESPASS UPON AND DO INJURY TO PUBLIC PROPERTY OR TO PRIVATE PROPERTY OF ANY PERSON OTHER THAN THE OWNER, KEEPER OF HARBORER OF SUCH DOG OR DOGS, ARE HEREBY DECLARED A NUISANCE AND EACH SUCH DOG OR DOGS SHALL BE SUBJECT TO BE IMPOUNDED.
- (d) NEITHER A DANGEROUS OR VICIOUS DOG, NOR A DOG WHICH BY LOUD, FREQUENT BARKING DISTURBS ANY PERSON OR NEIGHBORHOOD SHALL BE KEPT OR HARBORED WITHIN THE CORPORATE LIMITS OF THE CITY.

SECTION 9. ABANDONING DOGS UNLAWFUL. It shall be unlawful for any person or persons to bring within the City limits, any dog or dogs or other animals and abandon the same and allow them to run at large in the streets, alleys and public places in the City.

SECTION 10. STRAY DOGS. The enforce-

ment officers of the City are hereby authorized to destroy summarily any dog found at large in the City without any identifying check or tag showing the payment of the tax herein imposed, or any dog obviously a stray and not owned or harbored by any resident of the City as hereinbefore provided.

SECTION 11. DANGEROUS DOGS. The enforcement officers of the City may kill, without notice, any dog that is vicious, or is affected with rabies of hydrophobia, or any dangerous female dog running at large while in heat, whether it bears the tag herein provided for or not.

SECTION 12. UNLAWFUL BREEDS. It shall be unlawful for any person or persons to own, keep or harbor within the City limits any breed of PIT BULLDOGS or ROTTWEILERS.

SECTION 13. IMPOUNDED DOGS AT LARGE; NOTICE FEES; REDEMPTION; DISPOSITION.

(a). It shall be the duty of the Enforcement officers of the City or other persons duly appointed by the City Governing Body, to immediately take into custody and impound or kill, any dog found running at large in the City contrary to this Ordinance. If taken into custody and impounded, the dog shall be kept for seventy-two (72) hours and if claimed by any person, shall be delivered to such claimant upon satisfactory proof that he is the owner or is entitled to possession thereof and upon payment of the following fees and charges: (1) The sum of twenty-five dollars (\$25.00) for costs of impounding, feeding and caring for such dog for the first day and the additional sum of \$3.50, per day thereafter. Provided further, that if any dog so impounded does not have a current registration tag and a rabies vaccination certificate and the same is reclaimed by the owner, then the impounding officer shall give to said owner a registration form a duplicate of which shall be sent to the City Clerk, and such owner shall have three (3) days in which to comply with the Ordinance No. 55. If the owner redeeming said dog fails to comply with Ordinance No. 55 within three (3) days, then such dog shall be seized and reimpounded, and the owner shall have (3) days to comply with Ordinance No. 55. If the owner has not complied within the additional three (3) days, said dog shall be subject to disposal.

(b) If any dog shall not be claimed within seventy-two (72) hours after the impoundment of such, the dog may be killed in a humane manner, or may be sold by the Mayor for any reasonable sum and the proceeds paid into the City's General Fund. Provided, that any dog found at large and taken into custody which is carrying a metal tag for the current tax year may be returned to the registered owner of the dog if claimed, and, if not, the dog may be disposed of as in other cases. Provided, further, that any dog taken into custody which does not have a current registration tag and rabies vaccination certificate, and the same is reclaimed by the owner, then the impounding officer shall give to said owner a registration form, a duplicate of which shall be sent to City Clerk, and such owner shall have three (3) days to comply to Ordinance No. 55. If the owner redeeming said dog fails to comply with Ordinance No. 55 within three (3) days then such dog shall be seized and reimpounded and the owner shall have three (3) days to comply. If the owner has not complied within the three (3) additional days, said dog shall be killed in a humane manner, or may be sold by the Mayor for any reasonable sum and the proceeds paid into the City's General Fund.

SECTION 14. SPECIAL CONFINEMENT. Whenever the Mayor shall deem it necessary, either by danger of hydrophobia or rabies he or she may by proclamation require all persons to confine their dogs or securely muzzle them whether such dogs be registered or not, for such a time as may be designated in the proclamation, and, all dogs found running at large contrary to the requirements of such proclamation shall be killed, and the owner, keeper or harboring of such dog shall be guilty of an offense and subject to the penalties provided in the Ordinance.

SECTION 15. VISITING DOGS. The provisions of this Ordinance shall not apply to dogs not owned, kept or harbored within the City, which shall be accompanied and under control of the owners, keepers and harborers; provided, that any dog afflicted with rabies found in the City limits shall be immediately killed, and any dog suspected of rabies shall be impounded for a period of time required to determine if such dog actually has rabies.

SECTION 16. KENNEL LICENSES. No person or household shall own or harbor more than TWO dogs of six months of age or older or more than one litter of pups, or engage in the commercial business of breeding, buying, selling, trading, training, or boarding dogs.

SECTION 17. PENALTY. For each and every calendar year in which any person violates any of the provisions of this Ordinance, upon conviction thereof, he or she shall be fined in any sum not less than \$20.00 nor more than \$100.00 on the first offense and not less than \$50.00 nor more than \$ 100.00 on the second and third offenses, and \$100.00 per conviction thereafter which occurs in that same calendar year. This Ordinance shall be effective upon publication once in the official paper for the City of Menlo, Kansas.
