Colby Sweet Thunder second at state tournament

The Colby Sweet Thunder 18 & Under girls fast-pitch softball team finished second in the state Class B tournament, held at the Colby Recreation Fields over the weekend.

The tournament, featuring 13 teams in Class B, came down to a rematch of Colby and the Hays Strikers in two games. Colby won the first game 2-1, forcing a second game with matching records. The second game was also 2-1, but the Strikers came out on top.

Both Hays runs came on errors in the fifth inning. In the seventh and down 2-0, Colby tried to rally as they had done so many times.


