BE IT ORDAINED BY THE GOVERNING BODY OF THE CITY OF COLBY, KANSAS:

**SECTION 1. INCORPORATING UNIFORM** PUBLIC OFFENSE CODE. There is hereby incorporated by reference for the purpose of regulating public offenses within the corporate limits of the City of Colby, Kansas, that certain code known as the "Uniform Public Offense Code" Edition of 2001, prepared and published in book form by the League of Kansas Municipalities Topeka, Kansas. No fewer than three (3) cop ies of said Uniform Public Offense Code shal be marked or stamped "Official Code as Adopted by Ordinance No. 1316," and to which shall be attached a copy of this Ordinance, and filed with the City Clerk to be open to inspection and available to the public at all reasonable hours.

#### **SECTION 2. REPEAL.**

(a) Chapter Fifteen (15) of the Code of the City of Colby, Kansas, 1916 Edition, as passed and approved by Ordinance No. 905 on October 19 1976, is hereby repealed together with any amendments to said Chapter Fifteen (15).

(b) Ordinance No. 1295 is hereby repealed. SECTION 3. This Ordinance shall take effect from and after its passage and publication once

in the official city newspaper. PASSED AND APPROVED this 17th day of July,

#### **ORDINANCE NO. 1317** AN ORDINANCE REGULATING TRAF-

FIC WITHIN THE CORPORATE LIMITS OF THE CITY OF COLBY, KANSAS; IN-"STANDARD TRAFFIC ORDINANCE FOR KANSAS CITIES," EDITION OF 2001: PROVIDING CERTAIN PENAL-TIES AND REPEALING ORDINANCE WHEREAS, the City of Colby, Kansas, as au-

thorized under K.S.A. 12-3009 through 12-3012, including any amendments thereon, K.S.A. 12-3301 and 12-3302, to adopt and incorporate by reference the Standard Traffic Ordinance for Kansas Cities, Edition of 1999, as prepared and published by the League of Kansas Municipali-WHEREAS, the Governing Body of the City of

Colby, Kansas, finds it necessary and to the best interest of the City to adopt and incorporate by reference the said Standard Traffic Ordinance for Kansas Cities, Edition of 2001, as above

BE IT ORDAINED BY THE GOVERNING BODY OF THE CITY OF COLBY, KANSAS:

**SECTION 1. INCORPORATING STANDARD** TRAFFIC ORDINANCE. There is hereby incorporated by reference for the purpose of regulatng traffic within the corporate limits of the City of Colby, Kansas, that certain standard traffic ordinance known as the "Standard Traffic Ordi nance for Kansas Cities," Edition of 2001, prepared and published in book form by the League of Kansas Municipalities, Topeka, Kansas. No fewer than three copies of said Standard Traffic Ordinance shall be marked or stamped "Official Copy as Adopted by Ordinance No. 1317," and to which shall be attached a copy of this Ordinance, and filed with the City Clerk to be open to inspection and available to the public at all reasonable hours. The police department, municipal judge and all administrative departments of the City charged with enforcement of the Ordinance shall be supplied, at the cost of the City, such number of official copies of such Standard Traffic Ordinance similarly marked, as may be

**SECTION 2. TRAFFIC INFRACTIONS AND** 

deemed expedient.

(a) An ordinance traffic infraction is a violation of any section of this Ordinance that prescribes or requires the same behavior as that prescribed or required by a statutory provision that is classified as a traffic infraction in K.S.A. 82118.


(b) All traffic violations which are included within this Ordinance, and which are not ordinance traffic infractions, as defined in subsection (a) of this section, shall be considered traffic offenses

**SECTION 3. PENALTY FOR SCHEDULED** FINES. The fine for violation of an ordinance traffic infraction or any other traffic offense for which the municipal judge establishes a fine in a fine schedule shall not be less than \$10.00 nor more than \$500.00, except for speeding which shall not be less than \$10.00 nor more than \$200.00. A person tried and convicted for violation of an ordinance traffic infraction or other traffic offense for which a fine has been established in a schedule of fines shall pay a fine fixed

by the court not to exceed \$500.00. SECTION 4. REPEAL. Ordinance No. 1294 is

hereby repealed SECTION 5. EFFECTIVE DATE. This Ordinance shall be in full force and effect from and after its publication in the official City newspa-

per as provided by law PASSED BY THE CITY COUNCIL AND SIGNED BY THE MAYOR this 17th day of July,
