House approves patients' rights legislation this week

behind President Bush, House Republicans passed patients' rights legislation that scaled back lawsuits against guarantees from health plans such as HMOs that the Senate-passed version payment for emergency room visits would allow.

WASHINGTON (AP) - Rallying with this president, who has to sign this bill."

The bill grants patients a range of the right to appeal denials of care if they're harmed and access to courts through more-limited avenues than the Senate's Democrats offer. The fight over patients' rights will continue because congressional negotiators from the House and Senate must reconcile the bills' differences, mainly over how patients get to consumerfriendly state courts and how much money juries can award. There was no immediate word on when this House-Senate conference would begin, but in his statement, Bush pledged to extend "the hand of cooperation" to work out details. Hepatitis outbreak prompts vaccination effort

HUTCHINSON (AP) — With the Kansas State Fair about a month away, Reno County health officials are launching a vaccination effort against an outbreak of hepatitis A that has afflicted 58 people since last fall.

Health department director Judy Seltzer told county commissioners Wednesday that she has two or three weeks to "build a wall of protection" in preparation of the fair's Sept. 7th opening.

"If we can concentrate our efforts this to bed." now, we can close this window of infection before the fair begins," Seltzer said. The department is hunting down at-risk people for inoculation and encouraging restaurants to vaccinate their employees. Fair Manager Bill Ogg said he was concerned that the hepatitis A outbreak, if it continues, could hurt fair attendance. But he praised Seltzer's efforts to "take a proactive and progressive stance to put

Ogg said he has received several calls asking whether it was safe to come to Hutchinson.

"I'll tell anyone it's a safe and healthy and fun place to come to," Ogg said, adding that fair officials will reemphasize the importance of cleanliness to concessionaires before the fair begins. Details of the hunt for at-risk people, those with the greatest risk for contracting or transmitting the disease,

were still being worked out. But getting to one of the most at-risk communities, drug users, is expected to be difficult, Seltzer said.

"It's not like we can post a sign saying "vaccines today for drug users," she said. "We'll work with our contacts in the jail, in the (Kansas Department of Corrections), with drug rehabilitation centers and from our known contacts. You may see us in some strange places.

Briefly Weather: No change

The weather outlook for the Colby area tonight is calling for lows in the mid 60s with a 20 percent chance of thunderstorms. On Saturday, highs will again near the 100 mark with winds from the south at 10 to 20 mph. Saturday night, the story sounds the same, with lows in the mid 60s and again the chance of thunderstorms at 20 percent. Sunday highs are expected in the 95 to 100 range with a chance of thunderstorms and lows in the mid 60s. (The daily temperatures, precipitation and records are provided by the Northwest Kansas Research-Extension Center, Colby.)
