Kathy Cataldo introduced Bonnie Dible who is a parent support specialist with High Plains Mental Health at the Oct. 18 meeting. They indicated in their present expansion of services, High Plains Mental Health now also has the following personnel in our area: five families centered system of care case managers (for 6-18 year olds); five adult case managers; one child therapist; three adult therapists; four therapeutic preschools (for ages 1-5)

High Plains Mental Health is starting a couple psycho-social groups for youth to help them deal with their anger. Jamie Woods, the child therapist, will be conducting these training ses-
