AN ORDINANCE AMENDING SECTION 15-128 OF THE CODE OF THE CITY OF BREWSTER, KANSAS. PERTAINING TO MONTHLY RATES FOR WATER AND **SECTION 2-ORDINANCE 187 AND SEC-TION 3-ORDINANCE 187 PERTAINING** TO THE RATES AT THE WATER DOCK AND ESTABLISHING BULK RATES.

Be it ordained by the Governing Body of the City of Brewster, Kansas

SECTION 1. Section 15-128 of the Code of the City of Brewster is hereby amended to read as

15-128. MONTHLY RATES. The monthly rates for water supplied by the city shall be as follows: (a) Inside City. The rates for all users inside the city shall be \$6.09 minimum for

the first 3,000 gallons, \$.83 per 1,000 gallons for water consumed in excess of 3,000 gallons. (b) Outside City: The rates for all users outside the city shall be \$12.09 minimum for the first 3,000 gallons, \$.83 per 1,000

3,000 gallons SECTION 2, ORDINANCE 187. WATER DOCK. That Section 2, Ordinance 187, is tablished for water supplied at the water dock shall be as follows: A rate of \$1.50 for each

as a minimum rate. SECTION 3, ORDINANCE 187. That Section 3, ordinance 187, is amended to read as follows: Patrons will deposit \$1.50 in the water meter for each 1,000 gallons of Dock

1.000 gallons of Dock Water will be charged

BULK WATER. Bulk water rates will be \$1.50 for each 1,000 gallons of bulk water, or frac-SECTION 2. This ordinance shall take effect and


