Resolution to decade-old problem is being realized

Colby Free Press LEVANT—With more junk cars than residents, Levant citizens are fed up.

But an end may be in sight after coping with one man's junk for over a decade.

Residents in this unincorporated town have tried for more than a decade to remedy a situation created by Tom Hillary's salvage yard through the Thomas County Sheriff's Office and Thomas County Commissioners. Only until last weekend have they been able to see some satisfac-

The sheriff's office began on Sunday the task of towing away more than 50 vehicles which have been parked illegally for years.

"We tagged the vehicles for removal early last month," said Jim Engel, Thomas County deputy, "which gave Mr. Hillary 48 hours to relocate the vehicle that are parked illegally."

once Hillary was out of the hospital, he would make plans to remove the cars last weekend with the help of a friend, but as of late Saturday, none of them had been removed.

It was at that point the sheriff's department took over and set up the plans for Sunday, Engel said.

This morning, an upset Hillary confronted the Thomas County Commissioners at their meeting.

He told them he had made plans to move the cars by next weekend and was upset because they started the project without his notification.
