
Hadlie weighed 6 pounds and 4 ounces and was 19 inches in length. Grandparents are Alan and Kelly Focke of Colby.

One set is made of tin and one set is made from lava from the Mount Saint A very interesting program was Helens volcano. Abeautiful lace table-





Dear Friends:

The Board of Trustees of Citizens Medical Center, Inc. (CMCI), knows that the people of this community would like more information on the issues that are confronting CMCI. While we too would like for all the information to be made public, we take seriously our responsibilities under law to maintain confidentiality. We cannot talk about specific issues, but we can talk about what the laws require of any business in these situations.

Title VII of the 1964 Civil Rights Act, and the case law surrounding it, demonstrates the necessity for employers to provide a good work environment free from harassment and discrimination. This is the law that all businesses work under and must follow.

The Board of Trustees of Citizens Medical Center has a responsibility to the employees, physicians and patients of CMC to provide a safe working environment in compliance with the law. If we do not respond to a complaint, we may be subjecting the assets of this institution to countless lawsuits by any employee whose rights have been violated.

CMCI's corporate bylaws and medical staff bylaws have procedures for handling issues of this nature. An employee or practitioner against whom accusations are made is protected by a process of a fair hearing and an appeal hearing. It is this process that assures that all of the applicable information is brought forward, and from which the Board makes its final determination.

As a Board charged with the fiduciary responsibility of conducting CMCI's business affairs, we cannot ignore allegations, ignore state and federal laws and put the hospital's future at risk.
