Attorney general answers debt collection questions

Kansas Attorney General Dear Attorney General Kline:

I have fallen behind on a few of my bills. Now it seems like I get collection letters and phone calls from my creditors daily. I know that I owe the money, but the calls seem to come at all hours of the day and night. Are there rules that bill collectors have to follow when trying

Dear Kansas Consumer:

Any company attempting to col-Memorials may be made to the lect a debt is required by law to comply with the guidelines established by the Fair Debt Collections Practices Act (FDCPA).

Below are a few examples of questions that my office has received along with information that I hope will prove helpful to you:

What is the Fair Debt Collections Practices Act?

The Fair Debt Collections Practices Act (FDCPA) is a Federal law enacted in 1986 that provides a set of rules on how debt collectors should treat consumers and that prohibits certain methods of debt collection. This law does not erase legitimate debts owed by consum-

What types of debt collection practices are prohibited by the Fair Debt Collections Practices Act?

ample, debt collectors from doing such things as using threats of violence, publishing a list of consumers who refuse to pay their debts, falsely implying they are attorneys or government representatives or sending anything that looks like an official document from a court or government agency when it is not. They also may not misrepresent the amount of the debt, say you will be arrested if you do not pay your debt or give false statements about you to anyone, including credit bureaus. Many more restrictions apply, as

Between what times may a debt collector call me?

Debt collectors may not collect a debt at any time or place that the debt collector knows is inconvenient to the consumer. The FDCPA maintains that anytime between 8 a.m.-9 p.m. is presumed to be convenient unless the consumer has notified the debt collector other-

May a debt collector call me at work?

A debt collector may not call the consumer at work if he has reason to know the employer forbids such communication (for example if the consumer has specifically informed the debt collector that they may not

The FDCPA prohibits, for ex-receive calls of a personal nature he or she refuses to pay the debt or while at work).

May a debt collector call me at home on Sundays?

Once again, any day of the week between 8 a.m.-9 p.m. is presumed to be convenient unless the consumer notifies the debt collector to the contrary.

Are debt collectors allowed to use profanity?

All types of obscene profane and abusive language are prohibited by the Fair Debt Collections Practices Act. Abusive language would include religious slurs, profanity, obscenity, calling the consumer a liar or a deadbeat and the use of racial or sexual epithets.

What can I do to get debt collectors to quit calling me?

Once a debt collector receives written notice from a consumer that See "DEBT," page 8
