# S&Tto buy franchise

Free Press Editor A tentative deal between S & T Communications and Time-Warner Cable has been reached, said Mark Harrod, a spokesperson for Time-Warner in Stanford, Conn.

Amidst recent rumblings that Time-Warner franchises in Colby, Oakley and Trenton had sold to S & T Communications, Harrod confirmed that there was an agreement to sell the franchises, but the date of closing has yet to be determined.

"Time-Warner is normally in the business of acquiring companies," Harrod said today, adding that he was unsure about the exact details as to why those three franchises were sold. He did say that a tentative agreement was reached last Friday. More details of the sale will appear later.

## Storms damage Russell

RUSSELL (AP) — Thunderstorms with high winds and some tornadoes made their way through a handful of counties in north central Kansas this week taking down trees and power lines and causing property damage but only a few minor injuries.

"We had three storms converge on the county at once," Russell County Sheriff John Fletcher said. "One from the west, one from the northwest and one from the north.

"We're guessing somewhere besaid. "They were coming down so fast we couldn't keep track of them. Luckily, they wouldn't stay on the ground for long. They did enough damage doing what they did."

Fletcher said he had reports of damage to two houses, a barn and "a bunch of outbuildings and a whole lot of telephone poles."

He said officials planned to fly over the county Thursday to check for additional damage.

## Preliminary hearing on theft, burglary postponed

A continuance was granted for a 32-year-old Levant woman charged with multiple counts of burglary and theft involving prescription

Kimberly Anne Boardman's preliminary hearing was initially scheduled for mid-June in Thomas County District Court. However, a new date, said Allan Taylor, Thomas County attorney, has yet to be determined.

Boardman was charged with burglary, theft, and possession of narcotics and depressants that she allegedly took from the homes of coworkers and other individuals, said Gary Shull, Colby police investiga-

Shull also said their police investigation concluded that Boardman was alleged to have taken prescription medications from a home in the 1100 block of LaHacienda Drive, the 600 block of North School Av-
