



Christmas comes early for county

Colby Free Press The Thomas County Commissioners got what could almost be considered an early Christmas present at their meeting this morn-

During a brief visit with Gerald DeBoer of Penco Engineering, they found out the county will receive a \$310,000 economic development grant from the state for its Horton surer's office's tech fund. Avenue project.

DeBoer said the money won't be allocated until 2006 but that could be sooner possibly if they get finished plans.

The road project, which was discussed at the Dec. 13 commissioners meeting, will involve paving Country Club Drive from where it ends at the I-70 overpass to Horton a new copy machine and comput-Avenue. The commissioners don't know

when they will get the money or when their portion of the project will start but the city plans to start paving its part of the avenue next year.

'Particularly during this time of year, I figured whoever found it probably would keep it," she said. Behrens said the money was in a

bank envelope, but also enclosed was her paycheck stub and a picture of one of her granddaughters. 'The only thing on my check stub

The only thing missing from the envelope was a return address, Behrens said, as if the sender wanted to remain anonymous.

With tears in her eyes, Behrens said she just wanted to let whoever did this know how grateful she was.

"Bless you," Behrens said about her anonymous friend, "and have a Merry Christmas and Happy New
