# Council to rebid project

Free Press Editor Three bids received for the Colby Municipal Airport project were rejected during the council meeting earlier this week.

All three bids were over the engineer's estimates and one of the bids came in three minutes late, which disqualified it from consideration, said Carolyn Armstrong, city manager.

The three bids received for the airport apron/taxilane project included APAC-Kansas, Sporer Land Development in Oakley and Tarbet Construction, Colby. The base bids, Armstrong said, ranged from a low of \$490,000 from APAC to a high of \$513,513 from Tarbet.

Estimates were expected to come in at \$453,900. In addition to the airport project, bids on an alternate with approaches to private hangars ranged from lows of \$63,434 from APAC to a high of \$79,920 from Sporer, but again the estimates were targeted to come in at or around \$49,250.

The one bid that came in late, she said, was not opened.

According to the Kansas statutes regarding this type of situation, Armstrong said the council cannot enter into a contract for any work or improvement when the price ex-

ceeds the engineer's estimate. "As a council," she said, "you can

Colby Free Press An alert bank teller helped prevent a Colby man from being scammed for nearly \$4,000 on Thursday.

"He said he'd been in a MSN Hotmail chat room with someone who wanted to know how to get money for an airline ticket to the United States.

The woman on the Internet told the man she'd send him four money orders to cash and he was to send the money to two different addresses," Wagoner said.

The money orders presented to Peoples State Bank did not arrive through the post office, so mail fraud is not involved.

Krehbiel said when carriers such Scams such as the one Wagoner as FedEx or United Parcel Service are used for sending fraudulent money orders; it does not come under federal post office laws.

After some discussion, the council decided to reject the bids and took the next step by directing the city manager to get with HWS Consulting in Manhattan and look at changes in the scope or quantities of work. Armstrong said the consulting firm would review the project document and rebid it at no additional cost to the city. In making these types of changes, Armstrong said she is "very, very hopeful" to have good bids next time.

Timelines for the bid opening date is anticipated in late March with contract approval either at the council meeting on April 5 or April

"This should not result in a major delay on the project," she said.

## Bloodshed continues in Iraq with another dozen dead

The first blast occurred in Baghdad's southern Dora neighborhood near the al-Khadimain mosque, Iraqi National Guard 1st Lt. Ahmad Ali said. The mosque's imam, he

That explosion, Ahmad said, was apparently the work of a suicide bomber wearing a vest packed with explosives.

He said about 30 people were killed, though a hospital doctor, Ahmed Zaher, said 14 dead and 42 injured had been brought in from the blast.

A police official, Capt. Falah al-

Mahdawi, said 15 people were killed and 20 were injured.

Zaher said cars and pickup trucks were arriving at Baghdad's al Yarmuk hospital with more injuries. Shocked relatives were rushing through the hospital looking for relatives, he said.
