# Oakley resident takes agreement

Colby Free Press GOVE — An Oakley man has entered a year-long diversion agreement for vehicular homicide for the death of an Oakley teenager two years ago.

Blake N. Pilkington, 21, on Tuesday pleaded guilty in Gove County District Court to a traffic violation of driving too fast for surrounding conditions on Gove County Road S at 3:45 a.m. on Jan. 5, 2003, and having an accident.

That accident claimed the life of Cody M. Wilson, 18, of Oakley.

Pilkington was originally charged with four felonies, three misdemeanors and two traffic violations, with charges being filed only weeks before the statute of limitations ran out on Jan. 5. Gove County Sheriff Alan Weber said at the time charges were filed they were so long in being filed because he had "just laid (the case) down."

As part of a plea agreement, Gove County Attorney Mark Schmeidler, Quinter, dismissed all the charges against Pilkington except for the traffic violation. He amended the felony involuntary manslaughter charge down to misdemeanor vehicular homicide.

Pilkington sat quietly beside his attorney, Ronald S. Shalz, Colby, as Schmeidler told District Magistrate Judge Barbara Werner about the plea agreement.

"The blood alcohol content of Mr. Pilkington would probably not support a full DUI in count one or count two, and the state many have trouble proving it so the state is amending count one to vehicular homicide," Schmeidler said.

Schmeidler said Pilkington's blood alcohol was "greater than .02 but less than 0.8.'

State law sets the legal limit of alcohol in the blood at 0.8.

Terms of the agreement require Pilkington to attend the six-week long Prime for Life Under 21 alcohol program at the Regional Prevention Center of Northwest Kansas in Colby, or an equivalent program in Manhattan where he is a student at Kansas State University.

Pilkington is also to pay a diversion fee of \$120, a docket fee of \$152, a processing fee of \$45, a fine of \$200, and a community restitution fee of \$1,000.

The community restitution fee is to be paid through the clerk of the

# Mother, sister read impact statements

Colby Free Press GOVE — The mother and sister of an Oakley teen killed in a car accident more than two years ago gave impact statements during a hearing in Gove County District Court on Tuesday.

Janet Wilson and Amanda Scully, both of Garden City, told Blake N.

"I've been cheated so much. My ex-husband says he's been depressed, but my life has stopped," Janet Wilson said. Cody Wilson would have celebrated his 21st birthday on March 6.

Pilkington entered a plea agreement pleading guilty to a traffic violation of driving too fast for road conditions and entered a year-long diversion for vehicular homicide for Cody Wilson's death. Pilkington's attorney, Ronald Shalz, Colby, said he wanted the families involved to know the plea agreement his client entered had consumed a great deal of time and negotiation. "We didn't come to this agreement lightly. The perfect situation would be to bring Cody back, but we can't do that," Shalz said. Janet Wilson said she thinks Pilkington should be required to give more talks to teenagers about the effects of drinking and driving than the one required as part of the

Free Press Editor Someone broke into one of the business offices at Colby's hospital early Sunday evening, stealing money and checks, said Gary Shull, police investigator.

Similar types of thefts also occurred on Sunday and early Monday morning at hospital business offices in Oakley, WaKeeney and Goodland.

In the case of Citizens Medical Center, he said, the front door was still open because the theft happened between 6 and 8 p.m., which is still during visiting hours. However, the same wasn't so in the other three locations.

"Apparently the theft at Wa-



money was passing through the Shull said that whoever took the money left a trail of checks clear across College Drive and in ditches near the residential area of Summer Shull said today.

Sun. Janice McCart, chief executive officer at Citizens Medical Center, said the checks recovered were not from patients, but rather employees who had written them to the dietary department for meals.

Pilkington rolled the car he was driving just east of Oakley, killing Wilson, and injuring Casey L. Anderson, 17 at the time. Others in the accident, but not seriously injured, were Jeffrey C. Dennis, then plea agreement. 15, Robert D. Dennis, then 17, and Kyle A. Kersenbrock, 18 at the time.
