Brewster loses to Nebraska team

BREWSTER — The Brewster High School football team fell 49-20 to the visiting Hitchcock County (Trenton) Neb. Falcons in homecoming action Friday night.

The Bulldogs again struggled with consistency and injuries as they trailed only 6-0 in the first quarter and led 14-12 at one point in the second, but trailed 42-20 in the third.

Brewster's first drive started from the 15 after Hitchcock County, kicking with a 25-35 mile-per-hour wind, put the ball into the endzone.

The 'Dawgs moved out, moving 22 yards in seven plays until, on second and 10 from their 37, Branson Gilley was brought down for a five yard loss. Gilley was sacked again on third down and Brewster elected to punt on fourth and 20.

Seth Carpenter's kick went high and was caught by the wind, pushing it back for an eight yard loss and giving the Falcons good field position, which they would use to score first blood with 5:07 left in the first quarter.

The Falcons' 6-0 lead was the only scoring in the first quarter, but they scored again early in the second to lead 12-0 with 10:27 left in the half.

Kyle O'Connor ran the Hitchcock County kick back into the endzone, but was called back on a penalty.

That didn't stop Brewster, however, as they took the ball on their 30 and scored two plays later. First, Gilley ran to the Hitchcock 23.

Then he found O'Connor in the endzone for Brewster's first score of the game.

The 'Dawgs trailed 12-6 with 9:11 left in the half.

Then it was Hitchcock County's turn to kick into the wind. After being pushed back to their 13, the Falcon kick netted only eight yards, giving Brewster the ball on the Hitchcock 21.

Gilley found Carpenter three plays later for the touchdown and the 'Dawgs converted to lead 14-12.

Hitchcock County's next drive started on the Brewster 22 thanks to good open field running by Falcon fullback Tyrell Riggs.

Five plays later Hitchcock County again took the lead 20-12 and retained it until the half.

The Falcons opened the second half with a 44-yard touchdown run by Riggs and scored twice more in the quarter.

Brewster scored again as well; a 51-yard bomb from Gilley to O'Connor with 5:49 left in the quar-

ter. The Bulldogs were also forced to play most of the second half without lineman Garrett Smith, who came out in the third quarter with a shoulder injury.

The final score of the game came with eight minutes left when Riggs rambled 15 yards to make the score 49-20 Hitchcock County.

Gilley was 16-for-37 with 158 yards, three touchdowns and two interceptions in the air.

His primary receiver was O'Connor who had 12 catches for 100 yards and two touchdowns. Carpenter had three catches for 42 yards and a touchdown and Andrew Starns had a catch for 16 yards.

The Bulldog ground game was shut down early. Gilley had 24 carries for 72 yards and Starns had nine carries for 32 yards.

Defensively, Gilley led again with 16 tackles and three assists. Starns had eight and four, respectively. Phil Gralla, Corey Siruta and Cory Grantz had three tackles apiece. Siruta had four assists, Gralla three and Grantz one.

Seth Carpenter had two tackles and two assists and Ethan Kammer had one tackle and two assists.

The Bulldogs are at home again Friday against the Greeley County (Tribune) Jackrabbits. Game time is 7:30 p.m.

Lady Eagles earn third place

The Lady Eagles competed in an eight-team pool play tennis tournament on Tuesday, Sept. 13 and tied for third with Goodland overall as a team. Teams competing in our pool included Norton, Tribune and WaKeeney. In the other pool were Goodland, Ulysses, Garden City, and Scott City.

Liz Erickson stepped in and played for us at the #1 singles position. She went 1-3 for the day and finished in seventh place. She first played Jessica Cook of Norton and was defeated 7-0. She was defeated by Tribune's Celine Govert 7-0, was defeated by Leanna Newcomer of WaKeeney 7-0. She won by forfeit against Emma Kennedy of Garden City for 7th place.

"Liz had a difficult pool to play in," said head coach Mike Fortkamp. "Each of the ladies she faced won in the finals against the pool B finalist. The final score of her matches doesn't tell the full story of her play. She was taking on some senior state qualifiers from last year to deuce and lost the next point. Since this tournament had no ads she lost those close games. She played really well at times, but just needs to be more consistent and that will come with time and practice. Overall I was really pleased with

how well she played." At #2 singles foreign exchange student Gillian Zambrana took fifth place. She lost her first match 7-2 to Ashley Maybon of Norton. She was defeated by Morgan Schmidt of Tribune 7-1. She was defeated by Cassie Dietz of WaKeeney 7-5.

"The WaKeeney girl ended up taking first in #2 singles so I was really impressed that she came so close to winning and just came up short," Fortkamp said. "For only her second tournament of the year and limited practice time she did very well. We are glad to have her as a part of our team this year." In doubles Kaylie Dugger and Rashaun Wilson had a taste of #1 doubles competition. They were undefeated coming into the tournament playing #2s for Colby. They struggled early on in an overtime win, 7-6 (7-3) against a good Norton team comprised of Hannah Mills and Chelle Donovan.

"I was pleased that they were able to come back and win a tight match and come away with a win in the tiebreaker," Fortkamp said.

They struggled with Lindsay Wineinger and Kyra Wendt of Tribune who defeated them 7-3. In the third match they came back and defeated Julia Albin and Samantha

Augustine of WaKeeney and came away with a 2-1 record in pool play.

"I felt good about their chances at taking 3rd, but they continued to struggle against a Goodland team they beat at our Colby Invite," he said. "They were defeated 7-1 by Jena McCall and Sandy Johnson in the finals. They learned a lot from the #1 doubles experience and have a better idea of what it will take to make it to state. We will really have a tough test in Lindsborg on Saturday. That will give us a good idea of where we stand compared to the other 4A powerhouses like Wichita Collegiate and Marysville."

At the #2 doubles position, Lindsey Wilson and Stephanie Albers teamed up for a first place finish. They defeated Gena Myers and Sara Campbell of Norton 7-1, they defeated Colleen Fuller and Brittany Wendt of Tribune 7-3, and defeated Dana Diec and Amanda Gosser of WaKeeney 7-0. In the finals they defeated Scott City's Amanda Murphy & Kelsey Tankersley 7-4.

"It was their first varsity meet," Fortkamp said. "I was really excited and very happy for them. They played really well only losing 4 games in pool play. Scott City played them tough, but they came away with the win. I look forward to coaching them the next several years. I see a lot of potential in all of our ladies."
