The department seeks to work constructively with licensed establishments to ensure compliance with the Kansas Food Code, which protects the public from the risk of foodborne illness, said Sharon Watson, communication officer.

Whenever a food safety inspector identifies a violation, the inspector immediately notifies the person in charge and advises them on the proper way to make a correction. Violations are often corrected in this manner during the inspection. Where critical violations are not corrected with the inspector on-site, an unannounced follow-up inspection is conducted.

When an inspector documents state licensing requirements.

the same Food Code violation(s) on consecutive visits to the same establishment, it is the state's policy to issue fines. The fine for an individual violation can range up to \$500 per violation for each day the violation is documented. All fines are subject to appeal as governed under the Kansas Administrative Procedures Act.

By statute, an establishment has 20 calendar days from the date the order was mailed, plus three days for mailing to file for an appeal or to pay the fine. The Kansas Department of Health and Environment's purpose in issuing this advisory is to promote awareness of the Kansas Food Code requirements and

Police I Pepartment uses technology to catch criminals

Colby Police Department Sgt. searches Gary Shull found two sex crime suspects using the Internet and charges have been filed against both of men.

Shull located Andrais Thornton, 20, and Ontario McKee, 21, using the Internet search engine Google to help Thomas County Attorney Andrea Wyrick charge both with sex crimes.

Shull said, at first, he used Web sites available to only law enforcement officials to hunt the two men and came up empty.

Shull said after the two men left Colby Community College he knew they enrolled at a university in Missouri for the 2004-2005 school year. When the semester ended in May, he lost track of both Thornton and McKee, but located them until just recently.

Shull entered Thornton and McKee's names on a portion of the Google Web site which searches for information. The particular portion of Google's Web site e-mails the person requesting information if anything is found. Once the two were able to issue arrest warrants.

"I contacted both university po- according to the Missourian. lice departments to verify they were there," Shull said. "Then we issued warrants using their university addresses.'

Thornton was arrested Monday in Cape Girardeau, Miss., at Southeast Missouri State University where he's a starter on the basketball team. According to the Southeast Missourian, Thornton was suspended from the basketball team until his case is resolved. He has not been suspended from the school and his scholarship remains effective. If charges are dropped or Thornton is much easier than digging into a file

McKee was arrested Jan. 22 at San Angelo University in San Angelo, Texas. He pleaded guilty Jan. 26 to the lesser charge of sexual battery and was placed on probation. Information about his university or team status was not available. Shull said technology is an asset



Topeka man convicted of murder in fatal explosion

has been convicted a second time of murdering a woman and her 13month-old son in an Emporia apartment explosion in July 2001.

Jurors in Salina on Friday convicted Wallace L. Dixon III, 35, of two counts of felony murder. Dana Hudson, 19, and her son, Gabriel, were killed in the fire after an explosion in an adjacent apartment in the Eastgate Plaza complex.

Dispute could decide Kline's access to records

about how often doctors must notify authorities when they suspect teenagers are having sex could determine whether Attorney General Phill Kline gains access to patient records from two abortion clinics.

Kline, a strong abortion opponent, has clashed with abortion rights advocates in disputes in both federal and state courts. He testified in a federal court lawsuit Friday, even as the Kansas Supreme Court issued a ruling in a separate case.

The federal case involves his stance that health care providers must report all instances of suspected sexual intercourse involving minors under 16. The New Yorkbased Center for Reproductive Rights sued him over that position.

The Kansas Supreme Court's ruling came on Kline's attempt to gain access to the records from 90 patients from abortion clinics operated in Wichita by Dr. George Tiller and in Overland Park by Planned Parenthood of Kansas and Mid-Missouri. The justices sent the case back to Shawnee County District Court, telling a judge who subpoenaed the records to reconsider his

TOPEKA (AP) - Questions decision. Kline's chief deputy told the Supreme Court in arguments last year that the attorney general believes the records contain evidence of multiple violations of Kansas law. One statute at issue requires doctors and other health care providers to report cases of suspected child abuse to law enforcement, with the definition of abuse covering illegal sexual activity.

The jury acquitted on additional vated assault and two counts of aggravated battery. Dixon was scheduled to be sentenced in Lyon County District Court on April 24. In June 2002, Wheeler sentenced Dixon to two life terms with no possibility of parole for 20 years for the murder convictions.
