Daughter struggles to reveal details of her mom's violent death

DEAR ABBY: My mother was murdered by a serial killer about 16 years ago. Whenever the subject of parents comes up at work, I don't know what to tell people when they ask about my mom.

— MOTHERLESS DAUGH-TER IN WASHINGTON **MOTHERLESS** DAUGHTER: The fact that you become "nervous" when trying to discuss what happened to your mother means — to me — that you are still traumatized by the circumstances of her death. (Frankly, that's understandable.) When someone asks about your mother, it's not necessary to give chapter and verse unless you want to. Tell the person your mother passed away many years ago, which is the truth. If you are pressed for details, say that the topic is painful and change the subject. You are under no social obligation to bare your soul to
