# Federal inquiry finds district easy on pinching incident

WICHITA (AP) — A federal in-ulty, staff and students on the policy quiry has found that the Wichita County school district did not take appropriate action against a former high school principal who reportedly pinched a female student.

The report from the U.S. Department of Education's Office of Civil Rights showed that a Leoti USD 467 investigator found "inappropriate touching" took place about 18 months ago between a freshman girl at Wichita County High School and then-principal Duane Custer.

"However, the District failed to take appropriate action in response and maintained his innocence. to this investigation, including taking disciplinary action against the principal," the report said.

The report, released earlier this month, also said Custer was accused of making inappropriate remarks about other female students'

As a result of the federal inquiry, USD 467 agreed to settle the matter by reviewing and amending the district's sexual harassment policy. The district also must educate fac-
