#### William S. Ferguson

William S. Ferguson, long time resident of Ridgway, Colorado, passed away in March 2006 over come by cancer.

Bill was born in Colby, Kansas in 1947. His family was among the pioneers in Colby, owning the Thomas County National Bank for three generations. He had many childhood friends in Colby, where he played trombone in the junior band and was in a cub scout troop. In 1960 his family moved to Colorado where he graduated from Boulder High School. He worked in various construction trades and as a ski patrol man in Alta and Snowbird, Utah. He received his B.A degree from Western Washington State College in Bellingham Washington.

In 1977 he and his bride, Liza Clark settled near Ridgway, Colorado on a 35 acre tract in the Uncompangre River Valley in the San Juan Mountains. They built a home and started a nursery which soon thrived, producing and selling trees and plants that could survive at 8500 feet altitude. Landscaping contracts for the towns of Ridgway and Telluride and a Garden Center in Ridgway were other successful enterprises. Liza's parents, Tyler and Posey Clark from Connecticut, and her sister Mallory and her new family moved to Ridgway and helped in the nursery and garden shop business and bought more land in the valley. Bill grew into the cowcalf business, improving their water rights for hay production and leasing summer pasture in the high San Juanian mountain country. In the early 1990's Bill was instrumental in starting the Southwest Data Center which contracted work for the federal, state, and local government and for private ranchers and developers using GIS mapping technologies. He also opened a computer lab in Ridgway to help people enter the computer world. In 1999 he was appointed to fill a vacancy on the Ouray, Colorado Board of County Commissioners and was elected to continue in that post in 2000. As a water rights owner, he was appointed by the county to serve on the board of the Colorado River Conservation District, the oldest and largest water conservation board in Colorado. He also served on the Colorado River Water Users Association Board During his term on the Board, he was awarded a scholarship to attend the Kennedy School of Government in Cambridge, Massachusetts, where he learned a lot about arbitration and mediation among different view points in governing bodies. On February 14th, Congressman John Salazar honored him on the floor of the U. S. House of Representatives for his long and distinguished career as a rancher and public servant in Ouray County. His survivors include his wife, Liza, sons, Tyler and Roscoe, sister-in-law Mallory Clarke and her husband, John Clark of Ridgway, his father, David and stepmother Lois Ferguson of Denver, sisters Kate Marsters of Erie, Pennsylvania, and Denise Ferguson of Albuquerque, and brother Andy Ferguson of Denver.
