Board to revoke doctor's license

Hildyard expected to appeal decision in Thomas County **District Court**

A Colby doctor's license to practice medicine will soon be revoked following a decision Saturday by the Kansas State

Board of Healing Arts, the agency that regulates physician licenses.

Dr. Victor H. Hildyard, who has practiced medicine for more than 30 years, will lose his medical license once the final order is released, said Mark Stafford, the Kansas Board of Healing Arts' general counsel.

Hildyard was accused of 19 violations regarding misconduct and patient care.

The timeframe for when that final order is served to Hildyard was not available, but

Without stating their reasoning for the decision, as required by state law, the board voted to revoke Hildyard's license, which is now subject to appeal and review by the District Court of Thomas County,"

It was O'Neal's belief Board Chairman Roger D. Warren of Hanover was not happy with his assertion of Hildyard's right to have the review limited to the record created during a nine-day hearing in 2005.

Warren threatened license revocation as Mike O'Neal a remedy should Hildyard not testify, O'Neal said.

Stafford said it's not unusual for the board to request testimony "peer to peer." Had Hildyard agreed to testify in front of

the board, Stafford speculated it would have centered around "peer cases," but could not be more specific.

O'Neal said the board was "unpleasantly surprised" that their \$70,000 plus investment in the case had turned out in Hildyard's favor after the nine-day hearing.

"I believe the Board was looking for something they could add to the record to justify altering the hearing officer's deci-

sion," O'Neal said. Stafford could not comment.

"I need to wait to discuss this until after the final order is served," he said.

O'Neal said, by state law the board's final order must identify any difference between the final order and the hearing officer's initial order. It must include conclusions of law and any policy reasons for overturned.

the decision including the sanction.

Hildyard may seek a stay of the board's decision, either from the board or the Thomas County District Court, and to appeal the final decision.

Saturday's decision will be reviewed by the District Court of Thomas County. District Judge Jack Burr will determine whether to uphold the board's decision, reinstate the hearing officer's decision or make other findings.

"I was disappointed with the board's attempted disregard of Hildyard's procedural rights and for a decision that is so far afield from the facts in the record as to raise serious questions concerning the board's motives," O'Neal said today.

"It was apparent that the Saturday decision seemed to be based more on the board's attitude toward counsel's asserting Hildyard's rights than on any analysis of the

O'Neal said decisions by the board are to be in the best interest of patient care.

"This decision, if upheld, would actually be detrimental to patient care in northwest Kansas," he said. "What remedy do patients in Northwest Kansas have when the board takes action that is not in their best inter-

Stafford said the board will also ask for a stay of its decision at the district court if

An Atwood woman was killed in a two-car accident Sunday night.

Charges filed in fatal accident

A Colby woman has been charged with the death of two Colby people stemming from a car and motorcycle crash.

Dawnelle L. Umberger, 34, has been charged in Thomas County District Court with vehicular homicide for the unintentional deaths of Roger L. Blau and Roberta Casey.

Blau and Casey were riding a motorcycle Oct. 1, 2005, when Umberger is alleged to have failed to yield the right-of-way to them, a traffic infraction for which she's also charged.

If convicted, and depending on a presentence investigation, Um-

berger faces up to one year in the Thomas County jail and a fine up to

According to court documents, Umberger is alleged to have unintentionally killed Blau and Casey by operating her car in a manner which "created an unreasonable risk of injury" to them. She is also alleged to have deviated from the standard of driving care a "reasonable person would observe under the same circumstances."

Those same court documents state Blau and Casey were approaching Umberger when she failed to yield to them before crossing the road they were traveling. The accident took place on Range Avenue near Colby Bowl.
