Fireworks illegal within Colby

The Colby Fire Department is reminding residents that the use, sale, or possession of fireworks within the city limits is prohibited. When using fireworks outside the city limits, individuals will need permission from the landowner. In Kansas, the sale of fireworks started Tuesday and will continue until Wednesday, July 5, said Colby Fire Chief Bob McLemore.

Bottle rockets are illegal in the state of Kansas. It is illegal to shoot fireworks on or under a vehicle, on any public roadway, within 50 feet of a fireworks stand or where fireworks are stored and gas stations or any place liquid gas, including propane is stored, he said.

McClemore urges everyone to consider a safer and less expensive alternative, by planning to attend the fireworks display at 10:15 p.m., Tuesday, sponsored by the Thomas County Kiwanis Club.

Kansas improves in 'Kids Count' survey

higher among states this year in how its youngsters are faring, but a children's advocate said Tuesday that officials shouldn't be complacent about its relatively good marks in a national report.

The annual Kids Count survey rated Kansas 12th overall in child well-being, compared to 15th last year. The report was compiled by the nonprofit Annie E. Casey Foundation, of Baltimore, and based on 10 statistics that include dropout rates, infant mortality rates and the percentage of children living in single-parent households.

In six of 10 measurements, Kansas saw its numbers improve, while figures remained steady in two other categories. But the state saw

TOPEKA(AP) – Kansas ranked an unwanted increase in both the percentage of low birth-weight babies and the percentage of children in families where no parent has fulltime, year-round employment.

Generally, Kansas ranks well compared to other states, but Gary Brunk, executive director of Kansas Action for Children, said that's not sufficient when its children face global economic competition.
