## Turbine proposal denied

The wind will continue to blow in Thomas County, but won't power homes and businesses in the near

City of Colby officials have been informed a proposed wind turbine project south of Colby will not be coming. Wind would turn generators to produce electricity.

The project was proposed in the spring by J. W. Prairie Windpower, LLC from Lawrence and involved John Deere as a corporate investor. The City of Colby was interested in the project as an economic development prospect for Thomas County.

"Since the city of Colby does not have the equipment to purchase windpower directly from turbines, we encouraged Midwest Energy, our energy supplier, to consider the proposal from J. B. Prairie Windpower," said city of Colby Manager Carolyn Armstrong.

Turbines would stand 241 feet. Including the length of the turbine blades of 105 feet, the entire turbine would be 346 feet. Preliminary cost of each turbine is at least \$1 million. Each turbine can produce 1.5 megawatts of electricity, enough to power about 350 houses a year.

Midwest Energy recently informed Armstrong, J. W. Prairie had not been selected as a final candidate in their process. Midwest Energy's policy is "to accommodate renewable energy up to but not beyond the point where it would increase costs for our customer-

## Child center asks for \$5,000

Requests for county money continue to cross the desk of Thomas County Commissioners Ron Evans, Paul Steele and Ken Christiansen as they prepare the 2007

A \$5,000 first-time budget request was presented at Monday's meeting by David Fyler, co-director of the Western Kansas Child Advocacy Center with offices in Colby, Scott City and Sublette.

"We provide a child friendly space for children suspected of child abuse or sexual abuse," Fyler said. "We come along side law enforcement in investigating those types of crimes."

Accompanied by Thomas County Sheriff Mike Baughn and Undersheriff Jason Moses, Fyler said he and co-director Kelly Robbins, a former Kansas Bureau of Investigation Agent, were asking \$5,000 from each of the 26 counties the center serves. "We work closely with the cen-

ter," Baughn said. "We just aren't trained to investigate child abuse cases like those at the center."

Evans asked whether the staff at the center were duplicating services offered by others.

Fyler said "yes and no."

'It's really an all out effort to stop child abuse," he said. "This is the local effort on your part to have the center here. Our job is more the investigative piece. We try to find out the facts of the case.'

Baughn called the investigative services offered by the Western Kansas Child Advocacy Center law enforcement's best resource.

The center staff makes the child comfortable and their investigative tools are the best we've seen," Baughn said. "We rely heavily on their expertise."

A nonprofit entity, the three centers in western Kansas are among nine centers in Kansas and the 500 centers throughout the United States.

As of July 1, six Thomas County children had been provided services through the Western Kansas Child Advocacy Center.

Should the commissioners approve the center's budget request, it will make up 3 percent of the

center's \$139,000 budget. The center uses federal and state grants and donations from founda-

tions and individuals. "I appreciate the briefing you've

given us," Steele said.

"This is a topic that involves a lot of pain and I appreciate the education about the center.'

No decision was made.
