New council member Waldschmidt takes Beims' position

The Colby City Council recognized outgoing Councilman Mitch Beims during its meeting Thursday and welcomed Tom Waldschmidt to fill Beims' unexpired term.

Waldschmidt, 58, said Mayor Ken Bieber asked him if he would consider serving on the council.

"Since I consider this part of my civic duty, I agreed to serve," he said. "I believe we all need to step up and pay back to our communities when asked."

City Manager Carolyn Armstrong said Waldschmidt will be a valuable addition.

"I think he will bring a lot to the city council from his community perspective and business perspective," she said.

Thomas County's 2006 moisture better than last year

Nearly three and a half inches of rain between the beginning of June and now may seem like a lot. However, not every area in the Great Plains received that amount said Larry Boyd, a meteorologist with the National Weather Service in Goodland.

Data from the Northwest Research-Extension Center in Colby shows Colby has received 7.87 inches of precipitation since January.

Boyd said Goodland is 1.04 inches over its normal rainfall amount for this year, with 11.93 inches of precipitation since January.

Burlington, Colo., has had 4.04 inches of moisture, which is 4.9 inches below normal. Hill City has received 10.43 inches of rain so far, and is 1.78 inches below normal. McCook, Neb., is also below normal by 4.88 inches. It has only received 6.92 inches of moisture since January.

Boyd said there is no way to account for how one place gets more rain than another. "It's the luck of the draw," he said. "The rain just fell on our area.'

Compared to the 30-year average provided by the center, Colby's average for June is 2.64 and for July, 3.76. Colby is above its 30-year average, and even surpassed last June's rainfall amount of 3.12.

Data from the National Weather Service shows while the precipitation amount was more than last year, the amount of precipitation for the year so far is below average. enne County. Colby's average total for the same time period between 1971-2000 is about 10.1 inches

Boyd said May, June and July are the els an acre. wettest months of the year for the area.

Bad for wheat harvest, good for growing crops

Brian Olson, area agronomist with the Northwest Research-Extension Center, said the rain cause a few delays for wheat harvest. Now, however, the 2006 harvest is mostly over with the exception of some cutting still around Goodland and in Chey-

Olson said the rain kept farmers their out of their fields until now.

Wheat yields ranged from 0 to 40 bush-

"Twenty bushels was average," he said.

"Some spots were real good, some spots were real bad."

Recent rainfall has been a boon for farmers and their growing fall crops.

'It's been really good for them," he said. "It was definitely a good thing but we'll have to see what harvest brings."

The June precipitation has helped fall crops but more rain will be needed in a few weeks. Olson said corn benefited most from the rain. The crop was stressed, but has bounced back.

Rain also helped sorghum and sunflowers, which were planted after the corn.
