### ORDINANCE NO. 1405

AN ORDINANCE ADOPTING AND INCORPORATING THE UNIFORM PUBLIC OFFENSE CODE FOR KANSAS CITIES, EDITION OF 2006; REPEALING CHAPTER 15 OF THE CODE OF THE CITY OF COLBY, KANSAS, 1976 EDITION; AND REPEALING ORDINANCE NO. 1378.

BE IT ORDAINED BY THE GOVERNING BODY OF THE CITY OF COLBY, KANSAS:

#### SECTION 1. INCORPORATING UNIFORM PUBLIC OFFENSE CODE.

There is hereby incorporated by reference for the purpose of regulating public offenses within the corporate limits of the City of Colby, Kansas, that certain code known as the "Uniform Public Offense Code", Edition of 2006, prepared and published in book form by the League of Kansas Municipalities, Topeka, Kansas. No fewer than three (3) copies of said Uniform Public Offense Code shall be marked or stamped "Official Copy as Adopted by Ordinance No. 1405," and to which shall be attached a copy of this Ordinance, and filed with the City Clerk to be open to inspection and available to the public at all reasonable hours.

#### SECTION 2. REPEAL.

(a) Chapter Fifteen (15) of the Code of the City of Colby, Kansas, 1976 Edition, as passed and approved by Ordinance No. 905 on October 19, 1976, is hereby repealed together with any amendments to said Chapter Fifteen (15).

(b) Ordinance No. 1378 is hereby repealed.

SECTION 3. This Ordinance shall take effect from and after its passage and publication once in the official city newspaper.

### ORDINANCE NO. 1403

AN ORDINANCE AMENDING CHAPTER 18, ARTICLE 2, LOCAL TRAFFIC REGULATIONS, OF THE MUNICIPAL CODE OF THE CITY OF COLBY, KANSAS, PERTAINING TO PARKING ON RESIDENTIAL LOTS.

BE IT ORDAINED BY THE GOVERNING BODY OF THE CITY OF COLBY, KANSAS:

Chapter 18, Article 2, Local Traffic Regulations, Section 18-214.5., entitled "RESIDENTIAL PARKING REGULATIONS" is hereby added to read as follows:

#### ARTICLE 2. LOCAL TRAFFIC REGULATIONS

##### 18.214.5. RESIDENTIAL PARKING REQUIREMENTS.

(a) No motor vehicle, trailer, recreational vehicle, boat, or implement of husbandry as defined in the Standard Traffic Ordinance then in effect and as adopted by the City of Colby shall be parked on any lot in the R-1, R-2, R-3 and R-2 MH zoned districts except on a parking space.

(b) "Parking space" means a permanent surfaced area, enclosed or unenclosed, in size to store one (1) automobile, together with a permanent surfaced driveway connecting the enclosed or unenclosed surfaced area with a street or alley and permitting the unobstructed ingress and egress of a passenger car. The parking space shall consist of at least four inches (4") of hard surface material such as concrete, asphalt, rock, gravel, or other like material but not soil. Parking space may not be more than sixty percent (60%) of the front yard of any lot.

(c) These provisions shall not apply to the temporary parking of emergency motor vehicles, delivery vehicles and motor vehicles of public and private utilities.

This Ordinance shall take effect and be in force from and after its passage, approval, and publication as provided by law.

### ORDINANCE NO. 1404

AN ORDINANCE REGULATING TRAFFIC WITHIN THE CORPORATE LIMITS OF THE CITY OF COLBY, KANSAS; INCORPORATING BY REFERENCE THE "STANDARD TRAFFIC ORDINANCE FOR KANSAS CITIES," EDITION OF 2006; PROVIDING CERTAIN PENALTIES AND REPEALING ORDINANCE NO. 1379.

WHEREAS, the City of Colby, Kansas, as authorized under K.S.A. 12-3009 through 12-3012, including any amendments thereon, K.S.A. 12-3301 and 12-3302, to adopt and incorporate by reference the Standard Traffic Ordinance for Kansas Cities, Edition of 2006, as prepared and published by the League of Kansas Municipalities; and,

WHEREAS, the Governing Body of the City of Colby, Kansas, finds it necessary and to the best interest of the City to adopt and incorporate by reference the said Standard Traffic Ordinance for Kansas Cities, Edition of 2006, as above described.

BE IT ORDAINED BY THE GOVERNING BODY OF THE CITY OF COLBY, KANSAS:

SECTION 1. INCORPORATING STANDARD TRAFFIC ORDINANCE. There is hereby incorporated by reference for the purpose of regulating traffic within the corporate limits of the City of Colby, Kansas, that certain standard traffic ordinance known as the "Standard Traffic Ordinance for Kansas Cities," Edition of 2006, prepared and published in book form by the League of Kansas Municipalities, Topeka, Kansas. No fewer than three copies of said Standard Traffic Ordinance shall be marked or stamped "Official Copy as Adopted by Ordinance No. 1404," and to which shall be attached a copy of this Ordinance, and filed with the City Clerk to be open to inspection and available to the public at all reasonable hours. The police department, municipal judge and all administrative departments of the City charged with enforcement of the Ordinance shall be supplied, at the cost of the City, such number of official copies of such Standard Traffic Ordinance similarly marked, as may be deemed expedient.

#### SECTION 2. TRAFFIC INFRACTIONS AND TRAFFIC OFFENSES.

(a) An ordinance traffic infraction is a violation of any section of this Ordinance that prescribes or requires the same behavior as that prescribed or required by a statutory provision that is classified as a traffic infraction in K.S.A. 8-2118.

(b) All traffic violations which are included within this Ordinance, and which are not ordinance traffic infractions, as defined in subsection (a) of this section, shall be considered traffic offenses.

SECTION 3. PENALTY FOR SCHEDULED FINES. The fine for violation of an ordinance traffic infraction or any other traffic offense for which the municipal judge establishes a fine in a fine schedule shall not be less than \$10.00 nor more than \$600.00, except for speeding which shall not be less than \$10.00 nor more than \$200.00. A person tried and convicted for violation of an ordinance traffic infraction or other traffic offense for which a fine has been established in a schedule of fines shall pay a fine fixed by the court not to exceed \$500.00.

SECTION 4. REPEAL. Ordinance No. of 1379 is hereby repealed.

SECTION 5. EFFECTIVE DATE. This Ordinance shall be in full force and effect from and after its publication in the official city newspaper as provided by law.


