Dear Harlan,  
I just had to write after reading the letter from “rape victim who can’t find peace” named “J.” I went through the same things, and after 28 years of violent nightmares every night they suddenly diminished to maybe once or twice a year. Why? Because I tracked down the

rapist, and after he was sentenced, the nightmares miraculously stopped almost completely. I was brutally raped and sodomized for hours, then he proceeded to strangle me to leave no witness. I wrestled him away and somehow convinced him that I would never tell.  
ALL of my friends and family turned their backs on me too. When I tried to talk about it, they changed

the subject or looked bored until I stopped talking. Not a single one of my family offered any support whatsoever, nor did my so-called friends. I gave the media permission to use my name when I went to the sentencing because I wanted other victims to know that we should not be ashamed for what a rapist did to us. All of my so-called friends and family put me down for giving per-

mission and thought that was just awful. I actually hate them for that. So for J, please find someone who will listen, and don’t be ashamed for something that was not your fault.




