

Titans dominate Northern Valley

The Brewster-Triplains Titan High School football team got back on a winning roll by dismantling Northern Valley 72-22 in Almena Friday.

Everything did not go the Titans' way, however, as junior varsity running back Chris Williams came out late in the second quarter with an arm injury. Williams was carrying the ball when he was knocked down and either twisted or had the arm inadvertently stepped on in the pile.

He was transported by ambulance to Norton Hospital and later to Hays Medical Center for treatment.

The Titan defense scored first blood on a fumble recovery and 10-yard run by Corey Siruta and led 58-6 by the end of the first quarter.

The Brewster volleyball team took first place at regionals in Brewster and moved on to play at substitute in Ransom on Saturday.

The Lady Bulldogs defeated Tipton, 25-14, 25-7 for the championship and a trip to state.

Brewster will play Little River in the first round the Class A state tournament at 4:30 p.m. Friday on court

Northern Valley's only score in the quarter was a 79-yard kick return after Brewster-Triplains, first score.

The Titan junior varsity players saw a lot of action in the second quarter with the Titans staying far enough ahead to invoke the 45-point rule at halftime.

Besides Siruta, Brewster scored on 31 and 49-yard runs by Andrew Starns, an 8-yard run by T.J. Preston, a 27-yard pass from Aric Grob to Jance McKee, a 35-yard pass from Grob to Bryant Plummer, a fumble recovery in the end zone by Seth Carpenter, two punt returns, one by Carpenter and by Taylor Barrett, and a safety after a bad snap went through the end zone.

Grob was 2-2 for 62 yards in the air.

Starns had 93 yards on six carries. Plummer had three carries for 53 yards. Williams had one carry for 11 yards. Ethan Kammer had a carry for eight yards. Preston had four carries for four yards. Grob had three scrambles for six yards.

Williams also had six tackles. Plummer and Sam Smith had five each. Preston had four, as did Starns and McKee. Krystof Spurney and Boone Moser had two each. Carpenter, Clint Rogge, Barrett, Siruta, Kammer, Case Rundel, Seth Ackerman, Doug Hemken, Chance Cranston, Michael Collett and Tad Sheets each had one tackle.

Braden McKee and Lane Ochs each had an assist.

The Titans are 5-2 and finish the regular season 7 p.m. Thursday against Weskan in Winona.

At 6:30 p.m. Brewster plays Centralia and at 7:30 p.m. plays Bushton-Quivira Heights.
