Incumbent attorney general loses

TOPEKA(AP) — With many voters upset with Attorney General Phill Kline's pursuit of patient records from two abortion clinics. Democrat Paul Morrison easily ousted the Republican incumbent from office.

"Phill Kline has gone way over the line with what an attorney general should be doing with the abortion clinics," said Jeanne Blom, a 52-year-old pharmacist from Prairie Village who voted Tuesday for

Kline's race for a second term received national attention because of the abortion records dispute. With 99 percent of the state's precincts reporting, Morrison had 58 percent to Kline's 42 percent.

Morrison argued that Kline, an abortion opponent, had abused his office and violated patients' privacy. That argument appeared to overcome Kline's explanation that he needed the records to investigate crimes such as rapes with child victims and potentially illegal lateterm abortions.

"Tonight is a victory for people who believe the attorney general of this state should, above all else, enforce the law in a fair and evenhanded way," Morrison told supporters.

"It's also a victory for Kansans who want to make sure their most private, personal records are kept private.'

The race was nasty, especially when Kline resurrected 15-yearold, unproven sexual harassment allegations against Morrison — after Morrison had attacked Kline on various issues in television ads.

Voters haven't seen a race as contentious or bitter since Republican stalwart Bob Dole narrowly won reelection to the Senate in 1974. That year, abortion was a key issue, and Dole supporters asked how many abortions his Democratic opponent, physician Bill Roy Sr., had performed.

Commissioner votes may be recounted

Six votes split a highly contested commissioner race in Sheridan County, but all ballots may have to be recounted because of an equip-

Sheridan County Clerk Paula Bielser said a ballot counting machine "kicked out" 50 ballots which she does not know if the machine counted or not.

"We had some problems with the tabulator and of the 50 ballots, 15 of them are for Commission District No. 1." she said. Incumbent commissioner Ron

Schamberger, a Democrat, was facing off against Victor Bielser, a Republican, and the unofficial total stands in Schamberger's favor 220

While Bielser is not contesting the tally, Paula Bielser said the malfunction needs to reflect the correct totals for all candidates. Schamberger is a first-term commissioner for District No. 1, which covers the townships of Adell, Bow Creek, Valley, East and West Saline and one-half of East Kenneth Township, the east half of Hoxie.

"I think we'll have to recount all the ballots," Paula Bielser said.

Paula said she would be in contact with Secretary of State Ron Thornburgh's office to get direction about how to proceed.

Also wanting the commission seat was Bill Moore, a Republican from Studley, who waged a writein campaign and received four

Group to pick sheriff

The Sheridan County Republican Party will meet at 7:30 p.m. Monday at the courthouse to select someone to fill the unexpired term of Sheriff Jim Johnson, who was killed in the line of duty Oct.

According to Sheridan County Clerk Paula Bielser, the party will select the county's next sheriff and make its recommendation to Gov. Kathleen Sebelius. Sebelius will have 10 days to veto the recommendation or it becomes effective.

representation. Thomas and Sheridan counties had 142 in favor and 68 votes against.

Sheridan County voters who live in other school districts approved the same question. For Grinnell schools it passed 154-85; Grainfield schools 238 to 12; and Oberlin schools 659 to 364.

Incumbent Governor Kathleen Sebelius (D), received 537 votes in Sheridan County against Jim Barnett (R) who took in 458 votes. Another close race was between Incumbent Attorney General Phill Kline (R) who received 533 votes to Democratic challenger Paul Morrison with 449 votes.

The race for U.S. House Representative was a landslide for Jerry Moran (R) with 865 votes in Sheridan County, John Doll (D) got 125 votes to Sylvester Cain's (F) 4

votes.

Other wins were by incumbent Secretary of State Ron Thornburg (R) with 762 votes to Democrat David Healey's 154, Rob Hodgkinson (L) 21, and Joseph Martin (F) 18.

Incumbent State Treasurer Lynn Jenkins (R) had 725 votes to Larry Wilson's (D) 314.

Commissioner of Insurance Sandy Praeger (R) received 709 votes to Bonnie Sharp's (D) 199 and Patrick Wilber's (L) 33.

Kansas House Representative Jim Morrison (R) had 875 votes to Dannis Robison's (L) 43 and Art Richmond's (F) 49.

For State Board of Education, Sally Cauble (R) had 626 votes and Tim Cruz (D) had 288 votes in Sheridan County.


