CHARTER ORDINANCE NO. 171

A CHARTER ORDINANCE EXEMPTING THE CITY OF REXFORD, KANSAS, FROM K.S.A. 15-201, PROVIDING SUBSTITUTE AND ADDITIONAL PROVISIONS ON THE SAME SUBJECT, RELATING TO THE ELECTION OF THE MAYOR AND COUNCILMEMBERS, TIE VOTES, THEIR TERMS OF OFFICE AND THE FILLING OF VACANCIES.

BE IT ORDAINED BY THE GOVERNING BODY OF THE CITY OF REXFORD, KANSAS:

SECTION 1. The City of Rexford, Kansas, by the power vested in it by Article 12, Section 5 of the Constitution of Kansas, hereby elects to exempt itself from and make inapplicable to it K.S.A. 15-201, and to substitute additional provisions as hereinafter set forth in this ordinance. Such statutory section is applicable to this city but is not applicable uniformly to all cities.

SECTION 2. An election shall be held on the first Tuesday in April (each odd numbered year). At the April 2007 elections, there shall be elected a mayor and five (5) councilmembers. At the said election, the mayor and the two candidates for council member receiving the highest number of votes shall be declared elected for a term of four years. **The three candidates for councilmember receiving the next three highest number of votes shall be declared elected for a term of two years.** Succeeding elections for all such offices shall be for four year terms, or until the successors to such offices are elected and qualified.

Whenever there is a tie vote for two or more candidates and it is necessary to determine which candidate receives the office, the winner shall be determined by lot by the board of canvassers. The terms of the officers shall begin at the first regular meeting of the council in May following their election in April and they shall qualify by taking the oath of office.

SECTION 3. In case of a vacancy in the council occurring by reason of resignation, death, or removal from office or from the city, the mayor, by and with the advice and consent of the remaining councilmembers, shall appoint an elector to fill the vacancy for the unexpired term of that council position.

SECTION 4. In case any person elected as a councilmember neglects, or refuses to qualify within 30 days after election, the councilmember shall be deemed to have refused to accept the office and a vacancy shall exist. The mayor may, with the consent of the remaining councilmembers, appoint a suitable elector to fill the vacancy for the unexpired term of that council position.

SECTION 5. In case of a vacancy in the office of mayor, the president of the council shall become mayor until the next regular election for that office and a vacancy shall occur in the office of the councilmember becoming mayor.

SECTION 6. This ordinance shall be published once each week for two consecutive weeks in the official city newspaper.

SECTION 7. This is a charter ordinance and shall take effect sixty-one days after final publication, unless a sufficient petition for a referendum held on the ordinance as provided in Article 12, Section 5, Subdivision (c) (3) of the Constitution of Kansas, in which case the ordinance shall become effective if approved by the majority of the electors voting thereon.

Passed by the governing body, not less than two-thirds of the members elect voting in favor thereof, the 8th day of November, 2006.
