## Jury trial rare in Sheridan County

Sheridan County District Court is scheduled to conduct its first jury trial next month, the first one in almost 10 years.

The trial is scheduled to settle a lawsuit involving Hoxie Implement Company, Inc., owned by Gerald Heim, who alleges Cody Hoss of Gorham and Abdon Jaimes of Wichita, damaged several pieces of his equipment in an auto accident on March 7, 2002.

Heim is asking the court for a judgment in excess of \$75,000 in damages.

A jury pool of 100 residents have been notified by District Court Clerk Vergie Wente. Trial, with a jury of 12, will start Dec. 11.
