Now, it appears the 4th Brigade of the 1st Infantry Division will be meeting up with containers of equipment and supplies sooner than expected. President Bush's decision to increase the number of ground forces in Iraq means the 3,400 soldiers of the "Dagger Brigade" of the Big Red One will $leave \, Fort \, Riley \, three \, days \, ahead$ of schedule.

Lt. Col. Jay Pitz, brigade executive officer, said the change in plans had minimal effect on the soldiers.

The 3,400 soldiers heading to Iraq are part of the new strategy outlined Wednesday by Bush. His plan would raise troop levels in Iraq by 21,500 — from 132,000 to 153,500 — at a cost of \$5.6 billion. It also calls for the Iraqi government to increase its own forces and to do more to quell sectarian violence.

'We're going over prepared to conduct the full spectrum of combat operations," Pitz said. An exact deployment date is

not released by the Army.
