Parents paying for kindergarten

OVERLAND PARK (AP) -Kim Thai didn't spend extra money to send her oldest daughter to an allday kindergarten program in San Antonio.

So the Midwest transplant was surprised to learn she'd have to spend \$12 a day to send her youngest daughter. Isabelle, to a full-day program in a suburban Kansas City public school. "I thought everywhere was fullday," Thai said as she picked up her children from Sunrise Point Elementary in the Blue Valley school district in Kansas, where Isabelle is among 48 percent of 1,562 kindergartners enrolled in full-day programs. "To have to supplement the half day. To us, it was an automatic thing.' As all-day kindergarten grows in popularity, some districts are asking parents to pay for the extra costs of the longer program. Pay programs have critics, but proponents say charging is one of the best ways for districts to provide full-day programs in states like Kansas and Indiana, which only pay for half-day programs. And they say many parents accustomed to paying for child care and preschool don't flinch at the cost. Nationwide, 65 percent of kindergartners were enrolled in fullday programs in 2003, up from 28 percent in 1977, according to Washington, D.C.-based Child Trends DataBank, a national research organization.

Consumers must be treated fairly by law **By Paul Morrison** Consumer

Dear Kansas Consumer, Since taking office in January, the Consumer Protection Division of my office has received numerous

questions about debt collectors. The Fair Debt Collection Practices Act requires debt collectors to abide by a set of laws and treat consumers fairly.

While these laws will not erase any legitimate debt you owe, they do protect consumers against unethical collectors. If you have outstanding debt from credit cards, personal loans or a home mortgage, vou should familiarize yourself with some facts about the Fair Debt Collection Practices Act.

• Debt collectors may not contact you at inconvenient times or places. Debt collectors may contact you in person, by mail, telephone, telegram or fax during the hours of 8 a.m. and 9 p.m. Unless you agree to separate terms, a debt collector may not contact you outside of these hours, or contact you at work if the was sent and received. collector knows your employer disapproves.

from contacting you by writing them a letter.

Once a debt collector receives your letter, they may not contact you again except to notify you of tact my Consumer Protection Divisome specific action or to say there sion at (785) 296-3751 or toll free will be no further contact. that you have committed a crime or will be arrested, misrepresent the amount of your debt, or misrepresent the legality of any papers being sent to you.

If a debt collector has violated the law, you have the right to sue them in state or federal court within one year. You should report any problems with a debt collector to my Office of Consumer Protection by calling 1-800-432-2310 or by filling out the complaint form at www.ksag.org/consumers. Complaints may also be filed with the Federal Trade Commission by calling (877) 382-4357) or using the complaint form at www.ftc.gov.

To further protect yourself, always keep records of all correspondences and disputes with debt collectors. If a consumer disputes a debt in writing, send it certified mail in order to confirm that the letter
