Answers

1. TRUE. It turns out we’re not only the biggest liars, but some would argue we’re the only ones, and while animals might fake-out enemies, like by pretending to be dead, it doesn’t qualify as a true lie.
2. FALSE. While good manners and civility account for many lies, convenience, lying to ourselves to build self-esteem and to impress others, and lying and cheating to get what we want as well as to improve our image are more common reasons.
3. FALSE. If someone lies to you, the first thing to do is try to determine if you’re right and the person is lying, and then try to find out why he or she felt that the lie was necessary.
4. FALSE. Very young children are extremely imaginative, and there’s often a lack of boundaries between the imaginary world and the real world.
5. FALSE. In one survey, 20 percent of people admitted being unable to get through a day without telling a lot of premeditated white lies, and 91 percent said that they don’t regularly tell the truth or the whole truth.
6. FALSE. The greater the power a person has, the greater the danger
