

## Sheridan board unsure how to handle resignation

Neal and Slover's resignations follow Bette James' in August of 2004. So far, Sheridan County Commissioners have determined who will fill open seats on the hospital board of trustees.

When James resigned, three months after being elected, Sheridan County Commissioners Keith Kennedy, John Karls and Ron Schamberger appointed Craig Cooper.

Cooper, with 234 votes, was the fourth highest vote recipient in the April 2004 general election. In that election, James received 317 votes; Mary Karnes received 253 votes; and Neal received 249.

Neal was the only person to file for office for the election which took place on April 3. He received 295 votes, followed by Cooper who received 219 write-in votes which didn't count because he is currently on the board. Ronnie Kauk ran a write-in campaign and won a seat on the board with 196 votes.

Should Commissioners Kennedy, Schamberger and Doyle Kauk do as done in the past, they will look to former hospital trustee Ross Carder who got 100 write-in

Software issues lead to tax filing extension

WASHINGTON – Taxpayers who were unable to e-file their tax returns Tuesday using Intuit Inc. software products have until midnight on Thursday to file their returns, the Internal Revenue Service announced Wednesday.

Potentially up to several hundred thousand last-minute tax filers were affected by company server problems on Tuesday evening, and they TOPEKA (AP) - A Canadian or their accountants may have been unable to electronically file returns. Intuit confirmed Wednesday that those problems had been resolved, and it was successfully accepting efile returns on Wednesday.

Intuit product users who were unable to file their returns through the company's servers Tuesday should e-file as soon as possible. The IRS will not apply late filing penalties to taxpayers who were affected by this problem.

Overall, the IRS has seen a strong year for e-filing. Taxpayers filed more than 75 million returns electronically through April 17, shatter-

firm is coming to Kansas next month to conduct further tests on an unmanned aerial vehicle being developed for use by the military to drop cargo to troops in the field.

Officially called the CQ-10A "SnowGoose," the new UAV built by Ottawa, Canada-based Mist Mobility Integrated Systems Technology Inc. is designed to help the military get supplies to units in remote locations with minimal risk.

"This is a brand new machine. Traditionally, they are used for reconnaissance and communications. This is the first time for cargo," said Chuck Jarnot, a consultant for MMIST in Kansas.

Next month, the company will spend three days testing the SnowGoose at the Kansas National Guard's Great Plains Joint Training Center west of Salina. It is the first project to take advantage of an offer made last fall by Maj. Gen. Tod Bunting, the state's adjutant general, for companies to consider Kansas to come test and develop UAVs.

"We meant what we said and they took us up on it," Bunting said. "It's our airspace that's a national treasure."

The UAV has a payload of 1,400 pounds, including six bins capable of holding 500 pounds of supplies, communications, sensors or cameras. The range can be extended by reducing the cargo amount and increasing the fuel load. A complete system with two aircraft and launch system runs \$800,000.

The SnowGoose is designed to be air launched from the back of a military cargo plane, either a C-17 or C-130. It also could be launched out of the back of a modified Humvee. A parachute deploys and a 110-hp engine kicks in. The SnowGoose then flies to within a few hundred feet of the ground and drops supplies to awaiting troops.

"It doesn't need a runway, just a relatively short run on a road or the ground," Jarnot said.

The SnowGoose is supporting an Army research project and not for the company's own benefit


