TOPEKA (AP) - With six ofnine members' terms already expired or set to expire this month, Gov. Kathleen Sebelius has an opportunity to remake the board that oversees the state's higher educa-

"I would say in the next month or so, we'd have the six appointments," Sebelius spokeswoman Nicole Corcoran said Monday.

But the governor's decision to wait a full year to fill three positions on the Board of Regents was questioned by one former member. Former Senate President Dick Bond's term on the board expired in June 2006, but he served another nine months, resigning in March to recover from back surgery.
